"It is belaboring the painfully obvious to say that no library could possibly hope to build up a comparable collection by book purchases today . . . Therefore the col-lection will be found to be extremely rich in materials on political and social history in particular, and history generally. But, secondly, the period which these materials cover antedates the introduction of modern academic specialization, and individual works seldom fall entirely within the confines of a single academic discipline on the basis of presentday boundary lines. The materials will consequently constitute a major research resource for all social scientists and historians . . . "
