ANTHONY BEBBINGTON is professor of nature, society, and development in the School of Environment and Development at the University of Manchester, and an Economic and Social Research Council Professorial Research Fellow. His recent work addresses mining, hydrocarbons, and territorial development in the Andean region; social movements and poverty agendas in Peru and South Africa; and geographies of nongovernmental organization and action. She is also a senior fellow in the CSIS Global Health Policy Center. Before joining CSIS she was a foreign affairs officer at the U.S. Department of State, where she focused on health policy in Latin America and the Caribbean. Bliss is an adjunct associate professor at Georgetown University; previous faculty appointments include Smith College and the University of Massachusetts, Amherst. From 2000 to 2001 she was David E. Bell Fellow at the Harvard Center for Population and Development Studies. She is the author or coeditor of books, journals, and articles on public health, gender issues, and reform politics in Latin America, including the 2007 volume of *Sexuality Research and Social Policy*, "Nuevas direcciones: Sexuality, Politics, and Reproductive Health in Mexico," coedited with Héctor Carrillo and Matthew Gutmann; *Gender, Sexuality and Power in Latin America since Independence* (Rowman and Littlefield, 2006), coedited with

HILLARY HINER is a professor of history at the Universidad Diego Portales in Santiago, Chile. She is currently working on her doctoral dissertation, which seeks to historicize gender violence in contemporary Chilean society, at the Universidad de Chile.

JEAN E. JACKSON is a professor of anthropology at the Massachusetts Institute of Technology. She received her M.A. and Ph.D from Stanford University. Her 1983 book, *The Fish People: Linguistic Exogamy and Social Identity in Northwest Amazonia* examined the Tukanoan cultural complex of the Vaupés region. She has published numerous articles on the Vaupés peoples and on Colombia's indigenous movement. She is coeditor with Kay Warren of *Indigenous Movements, Self-Representation, and the State in Latin America* (2002). Jackson also conducted ethnographic research in a rehabilitation hospital in the United States, which resulted in several published essays and a book: "*Camp Pain*": *Talking with Chronic Pain Patients* (2002).

JUNE NASH is a distinguished professor emerita at the City University of New York, Graduate Center and City College. Her early fieldwork was in Chiapas, Mexico, where she worked with Mayas, publishing *In the Eyes of the Ancestors: Belief and Behavior in a Mayan Community* (1970, 1986), translated as *Bajo la mirada de los antepasados* (Mexico City, 1975, 1993). Her work in tin-mining communities of Bolivia resulted in the monograph *We Eat the Mines and the Mines Eat Us: Dependency and Exploitation in Bolivian Mining Communities* (1979), which received the C. Wright Mills honorable mention in 1980. Over the past two decades she has returned to study Mayas during the uprising in Chiapas, publishing *Mayan Visions: The Quest for Autonomy in an Age of Globalization*, 2001, translated as *Visiones Mayas: El Problema de Autonomia en la Era de Globalizacion*, in 2006.

ANDREW NICKSON is reader in Public Management and Latin American Development at the University of Birmingham, England, where he directs the Masters Programme in Governance and Development Management. His research interests include decentralization, urban water supply, and public-sector reform in Latin America. He published *Local Government in Latin America* (Lynne Rienner, 1995) and is coauthor of *Tapping the Market: The Challenge of Institutional Reform in the Urban Water Sector* (Palgrave Macmillan, 2003). His extensive writing on Paraguay includes *The Transition to Democracy in Paraguay* (Macmillan, 1997) and *Historical Dictionary of Paraguay* (Scarecrow Press, 1993).

AMY ERICA SMITH is a Ph.D. candidate in the Department of Political Science at the University of Pittsburgh and holds a master's degree in city and regional planning from Cornell University. Her research interests include electoral behavior, political participation, and social movements in Latin America. Her dissertation examines social networks and community associations in Brazil. SEYMOUR SPILERMAN is Julian C. Levi Professor of Sociology at Columbia University, where he also serves as codirector of the Center for the Study of Wealth and Inequality. His research covers issues in labor force attainment and the consequence of social origins for life chances and living standards.

PAMELA STARR received her Ph.D. from the University of Southern California (USC) in 1993. She is an associate professor (teaching) of international relations, the director of the U.S.-Mexico Network, and a senior fellow at the Center on Public Diplomacy at USC. Before joining the USC faculty, she was a senior Latin America analyst at the Eurasia Group and, from 1997 to 2005, a professor of Latin American political economy at Instituto Tecnológico Autónomo de México. She is a specialist on Mexican politics, economics and foreign policy, U.S.-Mexico relations, and economic policy making in Latin America. In addition to numerous articles, book chapters, and an edited volume, she is the author of a 2009 Pacific Council on International Policy report, "Mexico and the United States: A Window of Opportunity?" She is also the author of the 2006 Council on Foreign Relation's special report, "Challenges for a Postelection Mexico: Issues for U.S. Policy," and is currently working on two books, one on the political economy of dollarization in Latin America and a second on Mexico and U.S.-Mexico affairs.

FLORENCIA TORCHE is an assistant professor of sociology at New York University and assistant director of the Center for the Study of Wealth and Inequality at Columbia University. Her research examines the processes of inequality reproduction in the educational, occupational, income, and wealth spheres using an international comparative perspective.

MARK UNGAR is associate professor of political science at Brooklyn College of the City University of New York and of criminal justice at the CUNY Graduate Center. He is the author of a forthcoming book on citizen security reform in Latin America, and is completing an edited volume on community policing in the region. He has worked as police reform adviser in Argentina, Bolivia, Venezuela, and Honduras, and he has received grants and fellowships from the Ford Foundation, the Tinker Foundation, and the Woodrow Wilson International Center for Scholars.
