### Award

Sir Martin Roth was presented with an award for his pioneering studies on psychometric tests and clinical-pathological correlations in Alzheimer's disease at the Third International Conference on Alzheimer's Disease and Related Disorders which was held in Abano Terme, Italy from 13–17 July 1992. Sir Martin was presented with the award during the opening ceremony at the University of Padua on 12 July.

### William Inman Prize

The British Psychological Society, under the terms of a bequest in 1968, is responsible for the William Inman Prize. This prize is given for the best original work on psychosomatic ophthalmology in *The British Journal of Medical Psychology* or other medical journal approved by the British Psychological Society. The Society's Scientific Affairs Board recommends that the definition of "psychosomatic ophthalmology" be interpreted widely to include any research on psychosomatic factors in physical illness but especially those concerning the eye. Authors of published articles, their supporters and Journal editors are invited to submit to the Scientific Affairs Board eight copies of any article published in 1991 or 1992 which might be considered for the prize. ### New publications

The British Association for the Study and Prevention of Child Abuse and Neglect (BASPCAN) have announced the publication of the first issue of their new style journal. *Child Abuse Review*, edited by Kevin D. Browne and Margaret A. Lynch, will address current child protection and social welfare issues and reflect the concerns and views of the professionals who work to prevent child abuse and neglect. It will be published four times a year and will have an international focus on current clinical and social work practices.
