International Court of Justice: Bosnia and Herzegovina v. Serbia and Montenegro

In which the ICJ held, by a vote of 13 to 2, that Serbia had not committed genocide in violation of its obligations under the Convention on the Prevention and Punishment of the Crime of Genocide. By a vote of 12 to 3 the Court found that Serbia had nevertheless violated its obligation to prevent the crime of genocide pursuant to Article I of the Convention.

International Court of Justice: Pulp Mills on the River Uruguay (Argentina v. Uruguay)

In which the ICJ held by a vote of 14 to 1 that the current circumstances do not warrant it to exercise its powers of provisional measures pursuant to Article 41 of the Court's statute.

International Centre for the Settlement of Investment Disputes: World Duty Free v. Kenya

In which the Tribunal held that a payment made to former Kenyan President Arap Moi to obtain a contract was a bribe, and thus rendered the agreement a voidable one that ICSID would not enforce.

Israel Supreme Court: Public Committee against Torture v. Israel

In which the Israeli Supreme Court held that targeted killings are not always illegal, but must be examined in the context of the law of armed conflict and with respect to the international law norm of proportionality.

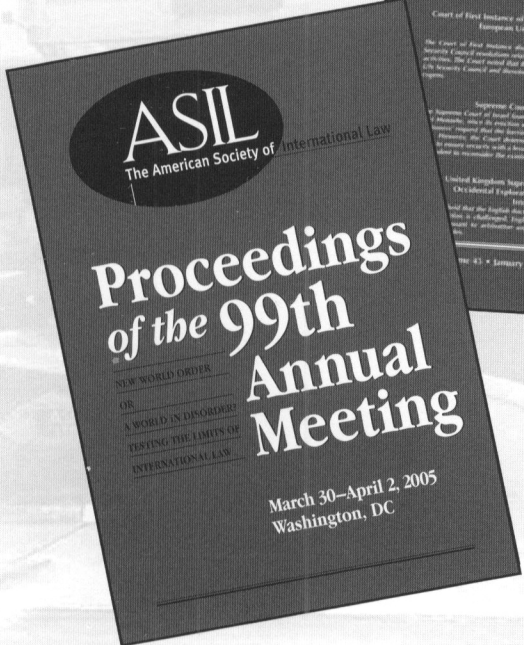
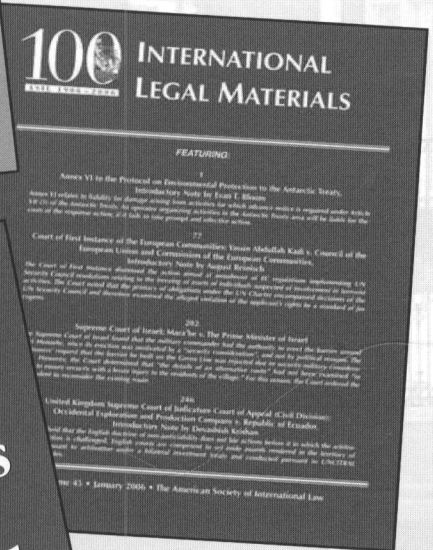
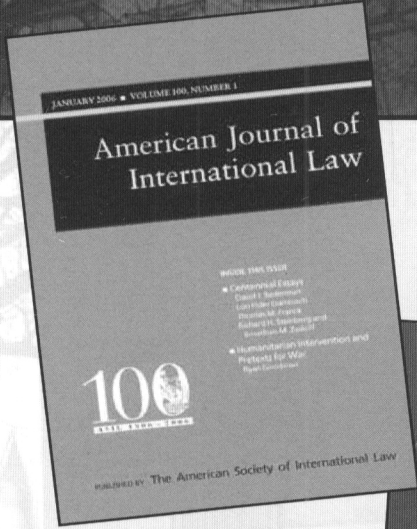
Henry J. Hyde United States India Peaceful Atomic Energy Cooperation Act of 2006

No legal scholar has been as passionate and articulate about the visual arts as John Henry Merryman. This new book, the Fifth Edition of his classic **Law, Ethics and the Visual Arts**, revised in collaboration with Stephen K. Urice, incorporates razor-sharp insights into numerous developments that have occurred in recent years, from the widespread bomb damage of the nineties to such specialized agreements as the UNESCO Convention on Protection of the Underwater Cultural Heritage. As readers have come to expect from earlier editions, historical underpinnings and patterns are clearly traced for every issue raised.

These issues include:

- “military necessity” as justification for destruction
- ugly, obscene, or offensive artworks as “free speech”
- fakes and forgeries
- the inner workings of art auctions
- laws relating to art crimes: who do they protect?
- trade in antiquities

A documentary appendix presents the texts of 23 relevant laws, conventions, treaties, declarations, resolutions, guidelines, codes professional practice, and the terms and conditions of sale of major art auction houses.

Although the last decade has witnessed more than a few episodes of shocking cultural destruction, Merryman and Urice note a great surge in worldwide consciousness of the unique, irreplaceable character of art, and a significant rollback of the cultural prejudices that have been ebbing away since the 1954 Hague Convention declared all art works, whatever their origin, to be “the cultural heritage of mankind.”

Whether you need to understand something as provocative as who owns the past, or something as mundane as whether a museum can sell part of its collection in order to fix the roof, this book will set you on the right course. It combines unassailable scholarship with a deeply humanistic approach, recognizing that law and art each (in the words of Paul Freund) “impose a measure of order on the disorder of experience without stifling the underlying diversity, spontaneity, and disarray.”

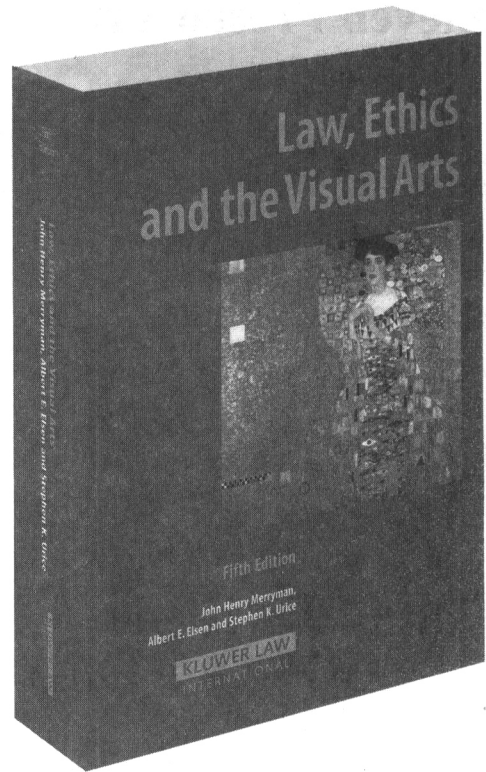

In this volume of *International Legal Materials*, the reader will note a concerted effort to increase the “intellectual content” of the publication by including a greater number of “Introductory Notes” to place the primary legal source materials in context. We are aware of the changing nature and availability of international legal documents, with more documents readily available on the Internet. This is quite a change from the relative difficulty of obtaining international legal documents when the American Society of International Law first published *International Legal Materials* in 1962.

The documents that appear in this volume reflect the variety and complexity of international law of our day. The Pact on Security and Stability in the Great Lakes Region concluded in December 2006, and which is now open for ratification, represents the efforts of the Presidents of the “Great Lakes” region of Africa to navigate important aspects of their relations, including peace and security, stability, sustainable development, and humanitarian, social, and environmental issues. The International Court of Justice case *Bosnia and Herzegovina v. Serbia and Montenegro*, is a seminal one, and likely to generate numerous law review articles for years to come. The International Court of Justice case *Pulp Mills on the River Uruguay* concerns the key South American nations Argentina and Uruguay and their dispute over control over portions of the River Uruguay. The International Centre for Settlement of Investment Disputes decision, *World Duty Free v. Kenya*, discusses an area of growing international concern and jurisprudence, official corruption. The Israeli Supreme Court decision was the last that A. Barak, the former President of the court, penned before leaving the bench, and it discusses the crucial concept of proportionality in the law of war context. The Henry J. Hyde United States and India Peaceful Atomic Energy Cooperation Act of 2006 represents an important development in the nuclear non-proliferation field.

Guidelines for Submission of Documents

The ILM Office welcomes any effort to bring suitable documents to the Office's attention. Electronic files or web links are required for publication, although printed texts can be used for initial deliberations regarding republication.

The authenticity (*i.e.* official version status) of submitted documents must be easily verifiable. This is facilitated by submitting files or print versions which are clearly attributable to the original source, or by providing links to documents on the original source's official website.

If the official version of a document is not available in English, an unofficial translation is acceptable. The original text must accompany such a translation.

Introductory Notes

Introductory Notes are brief articles from one to three pages in length which are intended to provide background information for a document reproduced in ILM.

For example, an Introductory Note for a treaty might include a short history of the negotiations, the dates of signature and entry into force. An Introductory Note for legislation would give its history and international significance, while one for judicial proceedings would provide the background of the case.

The views of authors in Introductory Notes are their own and do not necessarily reflect those of either the American Society of International Law or the Managing Editor.

Acceptance of Materials and Corrections

Print submissions cannot be returned. Translators and others submitting material will be notified of the acceptance of their document for publication.

Once a translation or Introductory Note has been accepted for reproduction, The American Society of International Law will send a publication agreement to the author.

Translators and Introductory Note Authors shall be acknowledged in *International Legal Materials*.

In some cases minor editorial or typographical alterations may be made without contacting the author or translator. Major corrections will be sent to the author or translator for approval. Corrected Introductory Notes or translations must be returned within the time specified.

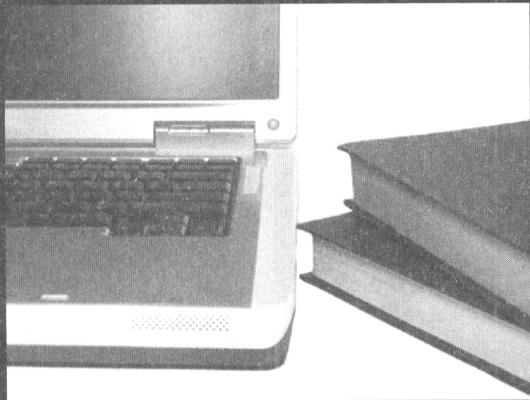
