


Fellowships for 2013 - 2014

The Center for Philosophy of Religion at the University of Notre Dame announces up to five fellowships for the 2013 - 2014 academic year: the Alvin Plantinga Fellowship (\$60,000), awarded to a distinguished senior scholar; up to two Research Fellowships (\$40,000 - \$50,000, depending on rank); the Frederick J. Crosson Fellowship (\$45,000) reserved for foreign scholars and those outside the field of philosophy; and one Visiting Graduate Fellowship (\$20,000) awarded to a graduate student in philosophy with research interests in the philosophy of religion and who would profit from spending a year at the Center. For the Visiting Graduate Fellowship, we give preference to students who are at the dissertation writing stage. The committee looks for applicants working on philosophy of religion either in or in addition to the applicant's dissertation.

- A statement of no more than 1,200 words describing the project on which you would like to work while at the Center
- A project abstract of no more than 150 words
- One published or unpublished paper




Analytic Theology Cluster Grants 2013

The Center for Philosophy of Religion, in partnership with the John Templeton Foundation, announces the Analytic Theology Cluster Grant program. With these grants we aim to support the formation of interdisciplinary discussion groups which will (a) bring philosophers and theologians together for regular conversation on a topic of mutual interest in or related to analytic theology, (b) provide financial resources for outside speakers to meet with the discussion group, and (c) incentivize particular outcomes that will have lasting impact in each participant's primary discipline. Each funded seminar will have two leaders – one theologian and one philosopher – and up to eight additional participants. The leaders must be faculty members; the participants may be either faculty or graduate students. Seminars must meet at least every other week for a combined total of at least 13 hours, over the course of one semester.

We will award up to five Analytic Theology Cluster Grants with a budget for each grant of up to \$15,000. Seminar leaders receive (i) \$2,000 each for developing the seminar syllabus, making meeting arrangements, and purchasing relevant texts, and (ii) \$7,000 together for funding at least two guest speakers, texts for the participants, and other expenses (refreshments, etc.). Participants receive \$500 each and seminar texts. In addition, each leader and each participant is eligible to receive an additional \$1,000 if within 12 months of the end of the seminar s/he submits either (a) a paper on the seminar's topic that is accepted for publication at a peer-reviewed journal or is incorporated into a dissertation in analytic theology, or (b) a syllabus for a course in analytic theology that deals with the seminar's topic and will be offered at the participant's or leader's home institution within the next academic year. To apply to be a seminar leader, please first submit a letter of intent not exceeding 500 words, along with a brief budget to analytictheology.project@gmail.com by **February 15, 2013**. Full proposals will be invited on a competitive basis. (Prospective seminar participants apply directly to the leaders after funding has been secured.) Awards will be announced by May 15, 2013. Analytic Theology Post-Doctoral Fellowships 2013 – 2014

The Templeton Analytic Theology Post-Doctoral Fellowships, administered by the Center for Philosophy of Religion at Notre Dame, will provide up to two one-year residential fellowships for the 2013 – 2014 academic year. These fellowships allow theologians to take a funded leave of absence to be spent in residence at a major center for research on philosophy of religion or philosophical theology.


The fellowships are open to full time faculty at accredited institutions who teach in theology, religion, or divinity programs. Applicants must outline a research program that will lead to scholarly publications in analytic theology or to new programs of study at their home institution. Fellowship recipients will normally spend one academic year in residence as fellows at the Center for Philosophy of Religion at Notre Dame. In exceptional circumstances, fellows may request permission to take their residential year elsewhere but (i) applicants must request permission to do so at the time of application and (ii) preference is given to applicants who take their year at Notre Dame.

Fellows receive a stipend of \$60,000 plus \$15,000 for relocation and research expenses. For further details, including sample topics of research, see our website: www.analytictheology.org.

The Editors and Editorial Board of The Journal of Ecclesiastical History are delighted to announce a major new prize in the field of early Christian History.

The Journal is offering an annual prize of £500 for the best essay submitted on a subject connected with any aspect of early Christian history, broadly undrstood as including the first seven centuries AD/CE. Scholars in any relevant discipline (theology, classics, late antique studies, Middle Eastern Studies etc.), whether established in their field or graduate students, are encouraged to enter the competition. The essays should not exceed 8,000 words, including footnotes, and for 2014 should be submitted by 30th September 2013. A judgement will be made at the end of November of the same year (the editors reserve the right not to award the prize if no essay of significant quality is submitted). The essay of the successful candidate will be published in the Journal, probably in the number appearing in July 2014. Other submissions entered into the competition may also be recommended for publication. All essays should be sent as two hard copies, prepared to journal style, to Mrs. Anne Waites, The Journal of Ecclesiastical History, Robinson College, Cambridge CB3 9AN.



Editorial policy

Religious Studies is an international journal devoted to the problems of the philosophy of religion as these arise out of classical and contemporary discussions and from varied religious traditions. Space is devoted to articles, of which more than 25 are published each year, but the journal also contains a book review section, which may include review articles and shorter notes as well as normal-length reviews.

1. Submissions

All contributions must be submitted via the electronic submission system at http://mc.manuscriptcentral.com/rst

No article will be accepted for publication without blind review. The text of submitted articles must be ready for this and must bear no trace of the author's identity. Articles that are not ready for blind review will be rejected.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. Upon acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their manuscript.

Books for review should be sent to Dr Christopher Hamilton at Department of Theology and Religious Studies, King's College London, Strand, London WC2R 2LS.

Books not selected for review will not be returned.

NB: Religious Studies does not accept unsolicited book reviews.

2. Manuscript preparation

Articles must be submitted as Word files to the journal and should not be more than 10,000 words long. Articles in two or more parts may occasionally be accepted provided each part is independently intelligible. They should be in English.

Each article must be submitted with an abstract of 100 words

When an article has been accepted for publication, the author must prepare their manuscript according to the journal style guide which can be found at www.journals.cambridge.org/res. Articles and book reviews will be checked and copy-edited for journal style and UK English.

The manuscript must be supplied in electronic format as Microsoft Word accompanied by a pdf of the same file.

3. Proofs

First proofs are sent to contributors by e-mail as PDF files. Corrections will only be accepted if they are sent to the Editor without delay.

Typographical or factual errors only may be changed at proof stage. The publisher reserves the right to charge authors for correction of non-typographical errors.

4. Offprints

Complimentary offprints are not supplied. Each Author will receive a pdf file containing their contribution to the journal, for their own use. Authors of Articles will also receive a copy of the journal.
