1982 Summer School On European Politics

The European University Institute is organizing the fourth Summer School on Comparative European Politics to be held in Florence from June 21 to July 9, 1982. The Summer School will admit up to 30 scholars, who should be university teachers or advanced doctoral students currently engaged in research work within the subject areas of the Summer School.

The aim of the program is to promote the comparative understanding of political development in Western Europe by offering an advanced program of lectures and seminars by leading international specialists. It is expected to act as a catalyst for future research and teaching in European universities.

The Academic Program

The Academic Program of the 1982 Summer School will have as a major theme the problems of *The Future of Party Government*, on which an extensive research project has been initiated by Rudolf Wildenmann, head of the Department of Political and Social Sciences of the European University Institute, and is being carried out in cooperation with a number of leading scholars throughout Europe.

The faculty of the Summer School will be mainly drawn from members of the research team of this project who are all leading experts in the comparative study of party systems, and will consist of Hans Daalder (Director of the Summer School), Ian Budge, Roland Cayrol, Karl W. Deutsch, Edward N. Muller, Gianfranco Pasquino, Gunnar Sjoblom and Rudolf Wildenmann, among others.

In addition, particular attention will be devoted to the comparative analysis of Southern European political systems, with special emphasis on Italy, in a series of lectures offered by leading Italian political scientists coordinated by Stefano Passigli.

Informal seminars in the afternoon will provide occasions for discussing the themes presented during the morning lectures. During these seminars participants are expected to present their own research work for general discussion by faculty members and other participants in the Summer School. Lectures and seminars will be conducted in English.

Admission to the Summer School will be based on the record of individual applicants. Each candidate is asked to submit:

- a short curriculum vitae, giving details of university degree(s), and past and present positions held;
- a list of publications;
- a statement on current research interests;
- the names of two referees who know the academic work of the applicant;
- a statement on knowledge of languages.

Applicants are advised that it is essential to contact their own universities or national grant-awarding bodies as soon as possible with a view to obtaining financial support for their attendance at the Summer School. It is hoped that the School will receive one or more grants similar to those awarded in previous years. This would enable the Summer School to contribute towards participants' travel and/or per diem expenses.

Summer Program Offered On Quantitative Methods

The Inter-university Consortium for Political and Social Research Training Program in Quantitative Methods of Social Research is a comprehensive, integrated program of studies in research design, statistics, data analysis, and social methodology. The Training Program's instructional environment differs from that of all but a few statistics departments in at least two respects:

1) Methods of quantitative analysis are

conveyed as part of the broader context of substantive social science research;

 To the degree appropriate all instruction is coordinated with and reinforced by active, participatory, data analytic experiences.

The Summer Training Program schedule is divided into two four-week sessions with instruction organized in lecture, seminar, and workshop formats. The first session will be held from June 28 until July 23 and the second session is scheduled from July 26 until August 20.

Program Design

The ICPSR Training Program is partitioned into three instructional tracks that are designed to satisfy the diverse research methodology needs and interests of most college and university faculty and graduate students in the social sciences.

Track I of the Training Program's curriculum consists of three courses: Elementary Mathematics for Social Scientists (lecture), Introduction to Computing (lecture), Introduction to Statistics and Data Analysis I (lecture/workshop).

These courses provide those college and university faculty and research scholars who are attempting to develop or upgrade their quantitative competencies with a basic integrated instructional program designed for that purpose.

Track II of the Training Program consists of 12 courses: Mathematics for Social Scientists (lecture), Mathematical Models of Social Phenomena (lecture), Experimental Studies (workshop), Introduction to Statistics and Data Analysis II (workshop), Introduction to Linear Models (workshop), Intermediate Linear Models (workshop), Applied Nonparametric Analysis (workshop), Multivariate Dimensional Analysis (workshop), Evaluation Research Methodology (lecture), Measurement Problems in the Social Sciences (lecture), Scope and Methods of Complex Survey Designs (lecture), Exploratory Data Analysis (workshop).

Prerequisites for the workshops at the Track II level are an elementary college

algebra course and a solid introductory course in applied statistics. Participants who enroll in the workshops will divide their time between attending classes and completing structured data analysis projects.

Track III courses fall into three categories. First, are those courses that belong to the statistics curriculum of the Training Program and will be meaningful only to participants who have satisfied prerequisites from Track II. In some cases, the content of these courses is on the frontier of the development of social methodology. They are: Advanced Topics in Statistical Modeling (workshop), Applied Multivariate Analysis (workshop), Causal Models (workshop), Discrete Multivariate Analysis (workshop), Models with Unmeasured Variables (workshop), Time Series Analysis (workshop).

Second, are those courses that are substantively oriented. The instructional focus is on the application of quantitative methods of analysis to particular substantive areas rather than on the learning of new statistical and mathematical techniques: *Empirical Research Issues in Aging (workshop), *Quantitative Analysis of Crime and Criminal Justice (workshop), Quantitative Historical Analysis (workshop), *Asian American Research Methods (workshop), *Empirical Research and Gender Issues (workshop). (*Stipend support is available.)

Finally, are those short workshops that address many of the common concerns of computing specialists and data librarians: Utilization of Data Resources from the 1980 Census (6/28-7/2), Current Microcomputer Applications (6/28-7/2, also 7/10-7/11).

International Library On Women in History Available in Microform

The Microfilming Corporation of America has recently produced *Women in History*, 13 microform collections about the organizations which and individuals who sought equal expression for women. Periodicals, essays, personal correspon-

dence, memoirs, biographies, organizational minutes, financial records, photographs and other documents enable researchers to explore the motivations, beliefs, actions, and consequences of women who affected modern history.

The microform edition of the Gerritsen Collection provides in a single resource, an entire international library relating the experiences of women both in the public arena – suffrage, the professions, education—and in the home. This library of 4,471 monograph titles and 265 periodical collections was begun in the late 19th century by Aletta Jacobs Gerritsen, a leading feminist and the Netherlands' first woman doctor.

She and her husband, Carl Gerritsen, brought together continental European materials printed in French, German, Dutch, Italian, Swedish, Norwegian, Danish, Czech, Hungarian, Spanish, Portuguese, Greek, Arabic, Latin, Polish, Russian, and English (printed in the U.S., Canada, Australia, New Zealand and the U.K.). In 1903, the Gerritsens' original collection was acquired by the John Crerar Library in Chicago and enriched with additional material focusing on the American women's movement.

The Kenneth Spencer Research Library at the University of Kansas acquired the collection in 1954 and it is from its holdings that the microform collection was produced. The editors of the microform edition have further enhanced the collection with the addition of materials from the major women's history holdings of the Walter Clinton Jackson Library at the University of North Carolina at Greensboro.

Monographs

Monographs in the collection reflect the Gerritsens' multilingual capabilities and interest in amassing a library for comparative studies of the international women's movement and women's attitudes and aspirations both in the home and the public arena. Major monograph topics include: marriage, home, and motherhood; anti- and pro-feminism; Congress, meetings, and lectures; women and war; education; employment; volunteer and philanthropic work; women and the arts; organizations and clubs; suffrage; legal status; women and religion.

Monographs (including pamphlets) are available in language series:

- English Monograph Titles (2,236): This collection represents a valuable collection for tracing the origins and growth of the suffrage and feminist movements in the English-speaking world. Also included are satires on women as their demands for equal rights increased, and dissertations on the physiology and psychology of women.
- German Monograph Titles (929): Included are writings on early feminist activities after the Revolution of 1848 and later works by leading feminists and jurists. Specific areas of interest include women and socialism, major women's conferences from 1869, and the German and Swiss women's movements.
- French Monograph Titles (734): The French monographs offer valuable scholarly surveys, biographies, autobiographies, pamphlets, histories, comparative studies, poems, and literary writings on a wide range of topics such as the role of women in industry, women in the military, prostitution laws, and feminist activities.
- Additional Monographs printed in Twelve Languages: The remaining monographs focus on comparative studies of the international women's movement.

Periodicals

Among the 265 periodical titles mostly collected between 1860 and 1900, there are 47 British periodicals; 80 American; 59 German; 24 French; 20 Dutch; 12 Scandinavian; and 9 Slavic language issues. Nearly all of these can be found in complete runs.

Library of Congress Revises Hispanic Directory

The Hispanic Division of the Library of Congress, with the joint support of the Tinker Foundation and the Organization of American States, has begun compilation of a new, completely revised and updated third edition of the *National Directory of Latin Americanists*. Since 1966, when it was first published, the directory has served as the basic reference tool for biographical and bibliographical data on Latin Americanist scholars in the social sciences and the humanities. For the new edition, the scope has been broadened to encompass specialists in Latin American agriculture and natural resources management, as well as those physical and biological scientists who actively define themselves as Latin Americanists through participation in a Latin American studies program or association. The core of the directory, however, will continue to be scholars in the social sciences and the humanities.

A new edition of the directory is needed, given the increase in the number of Latin Americanists in the United States since the second edition was published in 1971. As with the previous directories, the new edition will provide basic biographical and bibliographical data and will detail work experience, research interests, and current addresses for each individual included.

The directory will facilitate communication among professionals in the field and serve as a useful compendium for research and teaching institutions, development organizations, and national and international agencies in their search for scholars with Latin American expertise.

At present the staff of the Directory Project is still acquiring names and addresses of individuals who should be considered for inclusion in the new edition of the directory. Scholars whose work or research deals with countries of the Latin American region who have not yet received the *National Directory of Latin Americanists* questionnaire are requested to write for a copy to Inge M. The Advisory Opinion No. 3 (Permission to Reprint) was revised on April 30, 1977. The Opinion now reads:

ADVISORY OPINION NO. 3 REPRINT PERMISSION POLICY (October 11, 1969, revised April 30, 1977)

These guidelines apply primarily to anthologies or bocks of readings and do not diminish an author's right to quote from another scholar's work under the concept of "fair use."

Material to be reprinted should be clearly and fully identified. Any work reprinted may be changed only with the specific consent of the author.

The obtaining of legal permission to reprint from the copyright holder does not exempt the user from the ethical responsibility of informing the original writer in a timely manner that the material is to be reprinted, and an acknowledgement of the notification should be requested of the original writer.

The editor or user of material to be reprinted has an obligation to notify the original writer. Such notification should be sent to the academic affiliation of the writer with a request that it be forwarded to any new or temporary academic address. This notification should precisely describe the material intended for use and the specifications of the work in which it will appear.

Publishers are encouraged to make appropriate model reprint intent notifications available to editors of readers and other users. It is suggested that a sample of such a notification be included in the Publisher's "Guide to Authors."

If no response is received within three weeks of the sending of the initial notification the Associations agree that the editor's "good faith" responsibility has been fulfilled with the sending of a second notice describing the intended use.

The copyright holder and the author are each entitled to a flat fee or a share of royalties in connection with permissions to reprint, specific terms depending on agreement with the party seeking permission. Either the copyright holder or the e author may waive his rights. Each may act on his own behalf, or by mutual consent one may act on behalf of both.

Permissions must be renewed, and financial agreements are subject to renegotiation whenever a book goes into a new edition.

Any author is entitled to a complimentary copy of any publication in which his or her work is reprinted.
