FROM THE COURTS:

Helling v. Carey, 519 P2d 981 (Wash., 1974) (an ophthamologist is negligent as a matter of law for failing to test a 32 year old patient for glaucoma even if administering the test to patients under 40 is not standard medical practice. The court laid heavy emphasis on the facts that the test was relatively simple and inexpensive, and that failure to administer it in this case was the proximate cause of blindness.)

Memorial Hospital v. Maricopa Co., 94 Sup. Ct. 1076 (1974) (Arizona state statute requiring a year's residence as a condition to receiving nonemergency hospitalization or medical care at the county's expense is unconstitutional in that it creates an "Invidious classification" that impinges on the right of interstate travel by denying newcomers "basic ne-cessities of life." While Arizona is the only state that does not participate in the Medicaid program -which specifically forbids durational residency requirements -the reasoning of this case would apply to the "medically needy" in states whose Medicaid programs do not cover them).

Garlington v. Kingsley, 289 So. 2d 88 (La., 1974) (doctrine of charitable immunity abrogated)
Horne v. Patton, 287 So. 2d 824 (Ala., 1973) (a patient may sue a physician for breach of confidence on the basis of a common law duty which the doctor owes the patient, breach of privacy, or breach of an implied contract not to disclose information learned from the patient)
