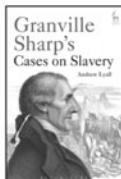

The purpose of this book is twofold: first, to publish previously unpublished legal materials principally in three important cases in the 18th century on the issue of

slavery in England, and specifically the status of black people who were slaves in the American colonies or the West Indies and who were taken to England by their masters. The second purpose is to give a social and legal background to the cases and an analysis of the position in England of black servants/slaves brought to England and the legal effects of the cases, taking into account the new information provided by the transcripts.

Public Inquiries Wrong Route on Bloody Sunday Louis Blom-Cooper

This book seeks to describe historically the use of public inquiries, and demonstrates why their methods continued to

deploy until 1998 the ingrained habits of lawyers, particularly by issuing warning letters in order to safeguard witnesses who might be to blame. Under the influence of Lord Justice Salmon, the vital concern about systems and services allotted to social problems was relegated to the identification of individual blameworthiness. The book explains why the last inquiry under that system, into the events of 'Bloody Sunday' under Lord Saville's chairmanship, cost £200 million and took twelve and a half years.
