EULAU to Edit Political Behavior Journal

Beginning with volume 2, the journal *Political Behavior*, published by Agathon Press of New York, will be edited by Heinz Eulau of Stanford University. Theoretically thoughtful but empirically grounded articles dealing with the political behavior of individuals, groups, organizations or institutions, whether approached in a psychological or sociological perspective, are welcome

To assure prompt attention and review, manuscripts should be typed double-spaced throughout and follow, in style and format of references, the *American Political Science Review*. Three copies of the manuscript should be submitted. A cover page should include title, author's name and affiliation, academic rank and mailing address. The manuscript should be accompanied by an abstract of 125 words. Tables should be typed on separate pages. All charts or graphs must be suitable for reproduction.

WOODROW WILSON Essay Anthology

The 1980s will mark the 100th anniversary of Woodrow Wilson's article, "The Study of Public Administration." Jack Rabin and James S. Bowman are preparing an anthology of original essays in recognition of this anniversary.

The purpose of the collection of original essays will be to examine the impact of the Wilsonian dichotomy on the principal subfields of public administration as they have evolved since the 1880s. These subfields include, but are not limited to, (1) organization theory, (2) administrative law, (3) budgeting, (4) personnel management, (5) administrative responsibility, (6) policy formulation, (7) scope and methods, and (8) the bureaucratic state.

Proposals for the 35-50 page articles are welcome from knowledgeable people specializing in these areas. Individuals are invited to send a one-page proposal and brief, tentative outline of their papers to: Jack Rabin, Department of Government, Auburn University at Montgomery, Montgomery, Alabama 36117; or James S. Bowman, Department of Political Science, University of Wyoming, Laramie, Wyoming 82071.

Proposals must be received no later than November 15, 1980. Complete manuscripts will be due in the fall of 1981. They will then be

refereed. Selected contributions will be published by a major book company in 1982.

LSE Department of Government M.S. in Political Philosophy

A new one-year M.Sc. in political philosophy will be established at the London School of Economics in the 1980-81 session. It is designed to explore in detail substantive problems in political philosophy and the approach will be both historical and analytical. The core of the course will consist of two small seminars: the first will explore the concept of justice in Greek political philosophy, and the second, the concepts of freedom and equality in modern political philosophy. Two additional parts of the syllabus will be selected from: (a) a choice of texts from authors such as Marsilius, Machiavelli, Hobbes, Locke, Rousseau, Hegel and J. S. Mill: or (b) a 10.000-word essay; or (c) an approved paper from another politics M.Sc.

The course is designed to enable students who have studied political philosophy or the history of political thought at undergraduate level to pursue in depth for a limited period several important aspects of these subjects. It will be an especially useful preparation for prospective research students as undergraduate courses in politics rarely include much specialization in political ideas. The concentration of staff who teach political thought at L.S.E. is unrivalled, and library facilities both at the School's new library and nearby are excellent.

The FRENCH-AMERICAN Foundation

The establishment of the first Chair in American Civilization at a French university has been announced by the French-American Foundation, whose purpose is the strengthening of ties between France and the United States.

The Chair, created to meet the rising demand from French scholars and doctoral students for access to specialists in American studies, will be situated in Paris at the Ecole des Hautes Etudes en Sciences Sociales, France's leading institution of higher learning in the social sciences. Beginning in the autumn of 1980, the Chair will be occupied by an American scholar in the social sciences to be selected by an academic committee headed by Professor Stanley Hoffmann of Harvard, with the agreement of the faculty of the EHESS.

Under the program, a different American professor will occupy the Chair each year for the next three academic years. These chairholders will be drawn from varying disciplines such as economics, history, and political science. At the end of 1982, the Chair will be expanded to become The Center of American Civilization at EHESS with additional courses offered by Americanists from other faculties in the French university system.

In recognition of the urgent need for a center in France where comprehensive and up-to-date knowledge about the United States will be presented on a continuing basis by American authorities in their fields, the French government plans to match the American program by creating a second Chair at EHESS in 1980. It has also been proposed that a major Documentation Center be developed in Paris to support the Chair and Center.

The French-American Foundation, a non-profit operating foundation, and its counterpart in Paris, the Fondation Franco-Americaine, were organized in 1976 to carry out a new program

of concrete projects in education, communication, and other fields aimed at bringing professional groups and young leaders in both countries closer together. The two foundations now spend over half a million dollars each year for this purpose.

Georgetown University BOWEN INTELLIGENCE, SECURITY and COVERT ACTIVITIES Collection

The Georgetown University Library has received on deposit from Colonel Russell J. Bowen a collection of more than 3,800 books on intelligence, espionage, covert activities, and national security. This collection has been placed in the Special Collections Department of the Joseph Mark Lauinger Memorial Library on the Georgetown University campus and will be identified as the "Russell J. Bowen Collection on Intelligence, Security and Covert Activities."

Colonel Bowen deposited this collection in the Georgetown Library because of his strong desire to have it used for the advancement of research, writing, and education pertaining to intelligence. The Bowen Collection will be available for use by scholars, researchers, and students in accordance with Georgetown University Library policies and procedures. The National Intelligence Study Center, directed by Dr. Ray S. Cline, is providing financial assistance for preparation and publication of a catalog which will facilitate access to and utilization of the collection.

The Bowen Collection includes books and documents of the United States, England,

France, Germany, Japan, USSR, and other countries. The scope of the collection extends over several hundred years, and includes early wars and conflicts in Europe, the American Revolutionary era, the Civil War in the United States, the World Wars and other events, Intelligence and espionage activities during World War II. the Cold War, and recent events are extensively documented in this collection. The Bowen Collection may be the largest body of published intelligence material in any university library.

Center for the Study of COMMUNICATIONS POLICY

The John and Mary Markle Foundation has awarded a three-year, \$450,000 grant to the Institute of Policy Sciences and Public Affairs for the continued support of a Center for the Study of Communications Policy. The program, to be directed by James David Barber, James B. Duke Professor of Political Science and Public Policy Studies, will attempt to equip journalists with the intellectual depth, self-conscious professionalism and standards of excellence needed to make the judgments our society now calls upon them to make. The program is aimed not at teaching journalism "technique," but rather will concentrate on an interdisciplinary, integrated program of substantive instruction and research, including the study of social journalism. It is expected that participants who enter the program will come equipped with academic expertise in various of the social science disciplines relevant to the study of communications policy.

The grant will focus on the creation of a Program for Contemporary Social Journalism and will stress curriculum development and research. It is also expected that several additional courses in journalism and communications policy will be developed at the Institute as well as internships to complement the courses. Further, several intensive summer courses for practicing journalists will be offered in substantive disciplines that are directly related to the work of the participating journalists.

AAAS Project on HEW Review Panels

CIA Academic Research Proposals

The U.S. Central Intelligence Agency is seeking preliminary proposals from individual scholars for unclassified research on the consequences of political and social change. Proposals of various sorts are encouraged, including analyses of individual countries, studies employing quantitative indicators across countries, and conceptual analyses which attempt to delimit the most

significant dimensions of political change. The proposed research should be described briefly in a 3-5 page prospectus that outlines the basic problem and approach, the resources to be employed, the related expenses to be incurred. and a rough estimate of the expected total cost. Expenses might include salary, travel, acquisition of data, and research assistance. The prospectus should be accompanied by a resume summarizing the individual's qualifications and experience for undertaking the proposed task. There are no restrictions on the project's beginning date of its duration. Each prospectus will be evaluated in terms of its relevance to current Agency needs, the merit of the proposal, and the qualifications of the individual or individuals involved. UK POLITICS Bibliography

The first bibliography that treats the United Kingdom as a 'multi-national' state has been published by the Centre for the Study of Public Policy at the University of Strathclyde. Laurence Pollock and Ian McAllister are the authors of A Bibliography of United Kingdom Politics: Scotland, Wales and Northern Ireland.

The bibliography lists nearly 2,000 entries to studies of politics in the non-English parts of the United Kingdom since 1945. It is particularly rich in references to unpublished papers presented at academic conferences or circulated privately. There are also entries to writings that compare parts of the United Kingdom with each other, to articles about the whole of the United Kingdom (not just Westminster-oriented politics), and to the Irish dimension in United Kingdom politics.

The volume appears under the aegis of the Political Studies Association Work Group on United Kingdom Politics (Richard Rose, Convenor; Peter Madgwick, Co-Convenor) and was supported by the Nuffield Foundation and the Social Science Research Council. It was compiled by computer, for ease in correcting and updating.
