Notes on Contributors

Pamela Ballinger is Fred Cuny Professor of International Human Rights and Associate Professor of History at the University of Michigan. She is the author of *History in Exile: Memory and Identity at the Borders of the Balkans* (Princeton University Press, 2003). She is currently writing a book exploring the arrival and reception in the Italian peninsula of 'national refugees' from the various territorial possessions that Italy lost after World War II.

Melissa Feinberg is Associate Professor of History and Women's and Gender Studies at Rutgers University. She has published widely on gender and politics in twentieth century Czechoslovakia, including *Elusive Equality: Gender, Citizenship and the Limits of Democracy in Czechoslovakia, 1918–1950* (University of Pittsburgh Press, 2006). She is an editor of *Aspasia*, a yearbook of women's and gender history in central, eastern and southeastern Europe. She is currently working on two projects: first, a monograph examining fear and political culture across Eastern Europe during the first decade of the Cold War, and second, a synthetic study of the communist era in eastern Europe.

Sam Goodfellow is Professor of History at Westminster College in Fulton, Missouri. He received his doctorate from Indiana University. His primary research interest is comparative fascisms and he has written *Between the Swastika and the Cross of Lorraine: Fascisms in Interwar Alsace* (Northern Illinois University Press, 1999). He is currently working on German identity in South West Africa from the 1920s until World War II.

Joachim C. Häberlen is a postdoctoral research fellow at the Centre for the History of Emotions, Berlin. He received his Ph.D. from the University of Chicago in 2011. A German translation of his dissertation entitled *Vertrauen und Politik im Alltag: Die Arbeiterbewegung in Leipzig and Lyon im Moment der Krise, 1929–1933/38* is forthcoming with Vandenhoeck & Ruprecht in 2013. He has published several articles in journals such as *Geschichte und Gesellschaft* (2010), *WerkstattGeschichte* (2012) and the *Journal of Global History* (2012). Together with Agnes Arndt and Christiane Reinecke, he has edited a volume on comparative and transnational history, *Vergleichen, Verflechten, Verwirren? Europäische Geschichtsschreibung zwischen Theorie und Praxis* (Vandenhoeck

& Ruprecht, 2011). Currently, he is working on a history of emotions in the New Left in Western Europe after 1968.

Jochen Hellbeck is Associate Professor of History at Rutgers University. He is the author of *Revolution on My Mind: Writing a Diary under Stalin* (Harvard University Press, 2006); and the *Stalingrad Protocols*, a book of previously unknown interviews with Red Army soldiers conducted in Stalingrad during the battle and shortly thereafter (available in German: *Die Stalingrad-Protokolle: Sowjetische Augenzeugen berichten aus der Schlacht*, Fischer, 2012; forthcoming in Russian with NLO publishers, Moscow). He is currently preparing a cultural history of the clash of the Germans and the Soviets at Stalingrad.

Michael Meng is Assistant Professor of History at Clemson University. He is currently working on a cultural history of Frankfurt's *Judengasse* since 1796 and on the intersections of memory and immigration in postwar Western Europe. With anthropologist Erica Lehrer, he is co-editing a volume of essays on Jewish space, nostalgia, and pluralism in post-Communist Poland.

Perry Willson is Professor of Modern European History at the University of Dundee (Scotland). Her previous publications include *The Clockwork Factory: Women and Work in Fascist Italy* (OUP, 1993); *Peasant Women and Politics in Fascist Italy: The Massaie Rurali* (Routledge, 2002) and *Women in Twentieth-Century Italy* (Palgrave Macmillan, 2009). She is currently researching the history of the Fasci Femminili as well as writing a book on everyday life in Fascist Italy for Oxford University Press.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

- 1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
- 2. a 100-word summary of the article in English, French or German
- 3. a short title for use as a running page-head
- 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
- 5. a short biographical note with a description of work in progress and previously published work (130 words max.)
