Mark O'Neill worked in museums in Glasgow from 1985 to 2009, latterly as Head of Arts and Museums in the city. ANNA BERGQVIST

Anna Bergqvist is Lecturer of Philosophy at Manchester Metropolitan University. Her principal research interests are aesthetics and moral philosophy, with special emphasis on meta-ethics and moral psychology. She is co-editor of *Evaluative Perception* (forthcoming with Oxford University Press). She has also published on narrative understanding, perspectivalism, aesthetic and moral particularism, thick evaluative concepts and selected issues in philosophy of language. She also works at the intersection between value philosophy and philosophy of medicine, and is currently preparing a monograph on particularism in medical epistemology.

SARAH HEGENBART

Sarah Hegenbart is a PhD Candidate at the Courtauld Institute of Art and College Curator of Art at Pembroke, University of Oxford. She is currently researching Christoph Schlingensief's participatory art project The Opera Village Africa in Burkina Faso, which brings together the longer narratives emerging from Germany's ambivalent facination with Richard Wagner and represents the culmination of Schlingensief's critical exploration of post-war German history that he carried out in his diverse artistic practice as filmmaker, theatre and opera director and performance artist.
