We learned recently that Michael Hanagan (Professor of History at Vassar, now Emeritus), our longest serving member, is retiring from the ILWCH Editorial Board. Mike was a participant in the journal's earliest years and has been among its most active contributors-a quick count lists almost thirty essays, book reviews, oral interviews, and contributions to our "Controversy" issues and round tables. The topics show an amazing range: nineteenth-century French artisans, the French state and labor, working-class formation, European welfare policies and household strategies, socialist parties, the new migration history, transnational labor trends and globalization. Mike's many books and edited collections are, of course, well known to labor historians. From Nascent Proletarians (1989) to his most recent works, Contention and Trust in Cities and States (2011, with Chris Tilly) and the co-authored Global Connections: Politics, Exchange, and Social Life in World History (2015), Mike's writings are prodigiously researched, ambitious in scope, and full of astute insights; they also exemplify the richness and constantly evolving character of labor history. We thank him for years of devoted service and wish him all the best in retirement; we will miss his observations and thoughtful engagement in our editorial meetings.
