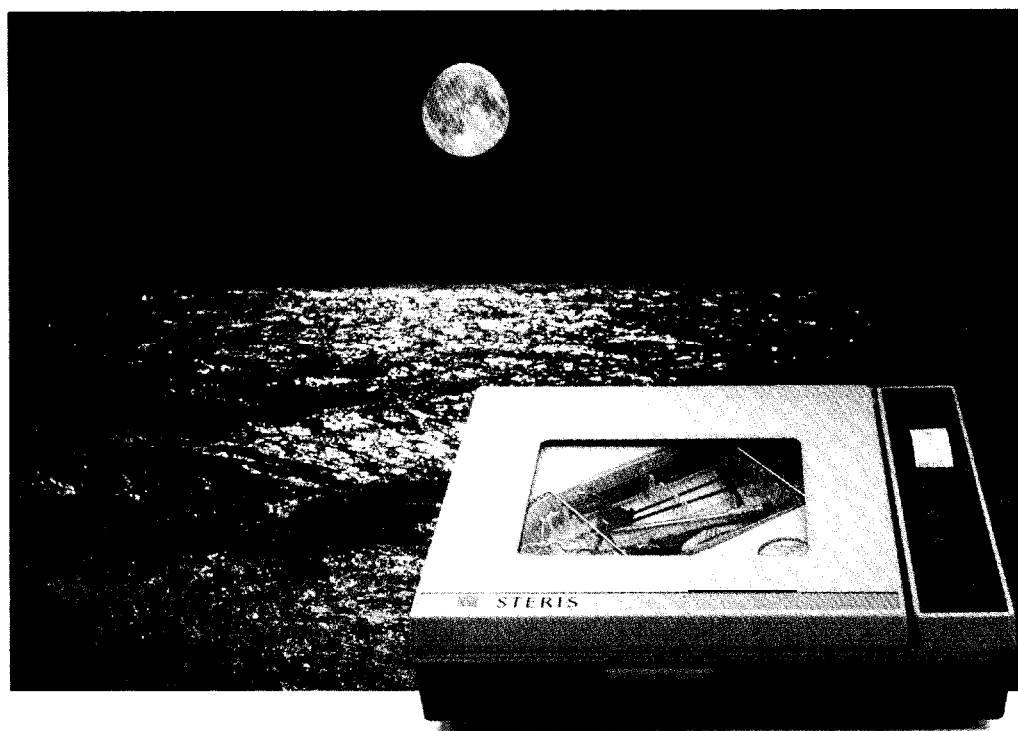

LIQUID STERILE PROCESSING

Q. How does liquid sterile processing compare to other methods?

A. Regardless of the sterilization process, the item to be sterilized must be clean to ensure effective sterilization. The cleaning process is universally performed by washing an item with water.
