CONTRIBUTORS

Alexander Rosenberg is the author of Microeconomic Laws, Sociobiology and the Preemption of Social Science, and The Structure of Biological Science, and coauthor of Hume and the Problem of Causation. He has taught at Dalhousie University, the University of Minnesota, Syracuse University, and the University of California at Santa Cruz. In 1982, he was the recipient of a Guggenheim Fellowship. He is currently Professor of Philosophy at the University of California at Riverside.

James S. Fishkin is Professor of Government and Philosophy at the University of Texas at Austin and, during the 1987–88 academic year, a Fellow at the Center for Advanced Study in the Behavioural Sciences at Stanford. He has a Ph.D. in Philosophy from the University of Cambridge and a Ph.D. in Political Science from Yale. He has previously been a Guggenheim Fellow and a Fellow of the Woodrow Wilson International Center for Scholars. He is the author of four books on moral and political philosophy: Tyranny and Legitimacy (Johns Hopkins, 1979), The Limits of Obligation (Yale, 1982), Justice, Equal Opportunity and the Family (Yale, 1983), and Beyond Subjective Morality: Ethical Reasoning and Political Philosophy (Yale, 1984). In 1985, he received the Erik H. Erikson Prize from the International Society of Political Psychology for Beyond Subjective Morality.

Hillel Steiner teaches political philosophy at the University of Manchester. He has contributed articles on liberty, rights, moral reasoning, and exploitation to various philosophical journals and will shortly publish *An Essay on Rights*. His current work includes a book on utilitarianism and (with Ian Steedman) a book on socialism and the market.

Onora O'Neill teaches philosophy at the University of Essex; she writes on Kantian ethics and political philosophy. Her most recent book is Faces of Hunger: An Essay on Poverty, Development and Justice (1986).

Alan H. Goldman is Professor of Philosophy at the University of Miami. He is the author of four books: Justice and Reverse Discrimination (Princeton University Press, 1979); Moral Foundations of Professional Ethics (Rowman and Littlefield, 1980); Empirical Knowledge (University of California Press, 1988); and Moral Knowledge (Routledge and Kegan Paul, 1988).

James W. Nickel is Professor of Philosophy at the University of Colorado, Boulder, where he also serves as Director of the Center for Values and Social Policy. He is the author of Making Sense of Human Rights, Philosophical Reflections on the Universal Declaration of Human Rights (University of California Press, 1987).

Barry R. Gross took his Ph.D. from the University of Toronto. He has been a visitor at the Institute for Advanced Study, a Visiting Scholar at the Columbia University Law School, and a consultant on the creationist case, McLean v. Arkansas. Among his publications are Discrimination in Reverse: Is Turn About Fair Play? and "Creation, Evolution, and The Constitution" (forthcoming). He has taught at The New School for Social Research and The New York State Hospital at Creedmore. He is currently Professor of Philosophy at York College of the City University of New York.

Bernard R. Boxill is Professor of Philosophy at the University of North Carolina at Chapel Hill. He received his Ph.D. in Philosophy from UCLA and was a fellow at the National Humanities Center in 1985–86. He has written articles in social philosophy and a book, *Blacks and Social Justice* (Rowman & Allanheld, 1984). He is currently working on a book on the problem of international distributive justice and national sovereignty.

June O'Neill became the Assistant Staff Director for Programs and Policy at the U.S. Commission on Civil Rights in March 1986. Prior to this, she directed a research program at the Urban Institute, where she specialized in the economics of women, population, tax policy, income security programs, and education. She has held numerous other government posts and, prior to her government service, she was a Research Associate at the Brookings Institution, where she authored two books on the economics of education. She has also taught at Temple University and the City College of New York, and is the author of many articles, papers, and books.

George Sher is Professor of Philosophy at the University of Vermont. He has published essays on a variety of topics in ethics, social philosophy, and metaphysics, and is the author of *Desert* (Princeton University Press, 1987). He is spending 1987–88 in residence at the Institute for Advanced Study in Princeton, NJ.

L.W. Sumner is Professor of Philosophy at the University of Toronto. He is the author of *Abortion and Moral Theory* (1981) and *The Moral Foundation of Rights* (1987), as well as numerous essays in moral and political philosophy.

David L. Kirp is Professor of Public Policy and Lecturer in Law at the University of California at Berkeley. His writings have taken as a central

theme the idea of fairness, as it is understood both in law and in politics, in the contexts of race (Doing Good by Doing Little [1979]), education (Just Schools [1982], and School Days, Rule Days [1986]), welfare ("The California Work/Welfare Scheme," and The Public Interest [1986]), and gender (Gender Justice [1986]). His current project, tentatively titled Hard Lessons, examines the moral dimensions of how American communities have responded to the AIDS crisis. Professor Kirp, who has been a columnist for the Christian Science Monitor and the Times Educational Supplement (London), also writes a syndicated weekly newspaper column.

Nancy A. Weston is a doctoral student in Jurisprudence and Social Policy at the University of California at Berkeley, where she is pursuing research in social and political aspects of law. Her current work explores political and economic influences on the development and interpretation of the civil rights laws, and on changes in civil and penal law resulting from mass industrialization early in this century. She holds a law degree from Harvard and has practiced civil rights and Sther public law since 1980. She also teaches at Golden Gate University School of Law in San Francisco.

Glenn C. Loury has published extensively in academic journals on a variety of topics in economic theory, including the efficient use of exhaustible resources under uncertainty, price determination in extractive industries characterized by seller concentration, and the long-run determinants of economic inequality in a market economy. His current research focuses on the politics and economics of racial inequality in the United States and will be presented in a forthcoming book entitled *Free at Last*.
