

Instructions for contributors

Editorial Policy

BioSocieties is an innovative new journal in the social sciences, dedicated to advancing analytic understanding of the social, ethical, legal, economic, public and policy aspects of current and emerging developments in the life sciences. These include genomics, neuroscience, psychopharmacology, biomedical and reproductive technologies, and biosecurity.

As the first journal of its kind, *BioSocieties* publishes scholarship across the social science disciplines, and represents a lively and balanced array of perspectives on controversial issues. In its first three years *BioSocieties* demonstrated the constructive potential of interdisciplinary dialogue and debate across the social and natural sciences. We are becoming the journal of choice not only for social scientists, but also for life scientists interested in the larger social, ethical and policy implications of their work. The journal is international in scope, spanning research and developments in all corners of the globe.

BioSocieties appears quarterly, with occasional themed issues that highlight some of the critical questions and problematics of modern biotechnologies. Articles, response pieces, book reviews, and self-standing editorial pieces by social and life scientists form a regular part of the journal.

Submissions

BioSocieties is a refereed journal; all manuscripts must consist of original material and are reviewed with the explicit understanding that their essential substance will not be submitted for review elsewhere until the editors have made a final decision regarding publication. Articles that describe the results of studies involving human subjects must give evidence that such studies have been subjected to appropriate ethical review.

The editors of *BioSocieties* are committed to publishing articles that are accessible and relevant to readers across a diverse set of social science and life science disciplines. Therefore all authors are strongly encouraged to submit manuscripts which are free of jargon, and which fully explicate potentially unfamiliar disciplinary theories and concepts.

Upon acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to the London School of Economics and Political Science.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright for worldwide publication in all forms and media, including electronic publication, and for ensuring that the appropriate acknowledgements are included in their manuscripts.

Manuscript Preparation

Please submit an electronic copy of the manuscript that meets the following requirements:

- A. Manuscripts should not exceed 10,000 words (including footnotes, but excluding references) and should be double-spaced and typed in Times New Roman, 12 point font. Please include consecutive page numbers on all pages, and arrange the manuscript in the following order:
 1. cover letter; 2. title page; 3. abstract and keywords; 4. main text; 5. acknowledgements; 6. references; 7. appendix; 8. figure captions; 9. tables and figures. Tables and figures should not be imported into the text. Attach manuscripts as Word documents and send to the Managing Editor: f.lentzos@lse.ac.uk.
- B. The cover letter should confirm that the manuscript is comprised of original material that is not under review elsewhere, and that study(ies) on which the research is based has been subject to appropriate ethical review. Authors must also note whether they have any competing interests, intellectual or financial, in the research detailed in the manuscript. The cover letter must be signed by all authors.
- C. Please include the following information on the title page: Name, email, and professional affiliation of all authors. Please note the corresponding author on the title page, along with telephone and fax numbers for this author. Please also provide a manuscript word count.
- D. An abstract of no more than 200 words should precede the text. Include six keywords for indexing purposes.
- E. References: Authors should comply with the guidelines set forth in the *Publication Manual of the American Psychological Association* (4th edition). The editors reserve the right to return manuscripts that do not follow appropriate APA citation format.

In-text citations should include the author's last name and date of publication, and may include page numbers; for example, Kramer (1993), Knapp, Scott & Davies (1999). If more than one citation is listed, citations should be in alphabetical order. Every in-text citation must be listed in the references section, and every reference must be cited in the text. Citations listed in footnotes must also be listed in the references section.

- F. Colour figures may be accepted provided that they contribute to the editorial content and are of a high quality. However, they are expensive to reproduce and the cost must be met by the author(s). A binding agreement to meet the costs will be required before the manuscript can be accepted for publication. Colour figures should be provided electronically in TIFF format or eps, to at least 300 dpi. Please also provide a printout of the illustration with exact instructions as to which part of the illustration is to be used, and where the illustration should be located within the text of the article.

Proofs

Typographical or factual errors only may be changed at proof stage. The publisher reserves the right to charge authors for correction of non-typographical errors.

Offprints

A pdf of each article and a complimentary copy of the issue in which the article appeared will be supplied free of charge to the first-named author.
