Once again Irving M. Copi has written a lively, modern logic text. This time a basic text for a first course in symbolic logic which stresses symbolic logic as a tool for appraising arguments, thus giving motivation to the student to master the material. It is adaptable to courses which stress the informal development of notations and methods for their use in appraising arguments, and is equally adaptable to courses whose main emphasis is on the development of systems of symbolic logic.

This book, written from a philosophically neutral point of view, presents the standard notations, methods, and principles of symbolic logic. The first half develops, in an intuitive, informal way, more and more of those notations and methods as they are required for the appraisal of more and more complex modes of argument. The second half of the book provides a more systematic treatment of the principles used in the first half. A great many exercises are provided, covering all parts of the material presented, thus helping the student to acquire a practical mastery of the materials - and to permit the class to spend more or less time on any given topic.
