

Morrow focuses on noncooperative game theory and its application to international relations, political economy, and American and comparative politics.



MANAGING THE WORLD ECONOMY: Fifty Years after Bretton Woods Peter B. Kenen, editor

The international economic order established at Bretton Woods, New Hampshire in 1944 has contributed significantly to world growth and stability. But the world economy will be very different in the 21st century due to the end of the Cold War, the advent of new economic powers, and the globalization of markets and companies. The Group of Seven major industrial democracies, at their Naples summit in July 1994, decided to consider "What framework of institutions will be required to meet the challenges of the 21st century?" and "How can we adapt existing institutions and build new institutions to ensure the future prosperity and security of our people?"

This volume presents the results of an Institute conference at which leading experts and policymakers assessed the record of the Bretton Woods regime over the past half century and the need to modernize the system now. Specific proposals are made for reforming the international monetary and trading systems, including through changes in the roles of the International Monetary Fund, GATT and the new World Trade Organization, and the World Bank. The volume also assesses the case for creating new institutional arrangements to address several issues that have recently attained greater prominence on the global agenda--investment, financial markets, the environment, and migration. C. Fred Bergsten provides a concluding paper that purposes major changes in existing institutions and creation of new ones to meet the challenges of the future.
