"The Strimple Award is given to recognize outstanding achievement in paleontology by amateurs. The criteria for making the award may include a record of outstanding research and publication, the making of outstanding collections, the safeguarding of unique paleontological materials through varied public service approaches, teaching activities dealing largely with paleontologic topics, and collaborative efforts with others working in paleontology.
