SUBMITTING PAPERS

Papers should be sent to The Editor, British Journal of Nutrition, 10 Cambridge Court, 210 Shepherds Bush Road, Hammersmith, London W6 7NJ. They should be written concisely and must represent the results of original nutritional research or a new interpretation of existing knowledge not previously published. Full requirements and details of how papers should be prepared are given in Directions to Contributors printed in Part 1 of each volume but authors should also consult a recent issue to acquaint themselves with the style and conventions of the Journal. Submitted papers (three copies) should be accompanied by a signed statement to the effect that the author accepts the conditions laid down in Directions to Contributors.
