Takeaways From SHEA's Seventh Annual Meeting

SHEA's annual scientific meeting in St Louis featured scientific presentations at 14 concurrent and 4 plenary sessions, 170 poster presentations, and 6 Meet-the-Consultant Breakfasts. Many of the 750+ registrants present were looking for ideas to use or to explore further at their own institutions. Of the hundreds of examples that were addressed at the meeting, these two are highlighted: At their Meet-the-Consultants Breakfast, the CDC's David Bell and San Francisco General Hospital's Julie Gerberding shared with participants the practicalities of administering the new HIV postexposure management guidelines published in *MMWR* this past year. Although her goal remains to initiate postexposure prophylaxis with two or three antiretro-

virals, when appropriate and as rapidly as possible, Dr. Gerberding pointed out that, at her center, a 4-hour postexposure interval until the first dose of medications ingested by the exposed HCW is not considered unreasonable.

The interaction between infection control and process improvement was illustrated well in a storyboard poster presented by the University of Pennsylvania's Maryann McGuckin, "Did You Wash Your Hands? A Handwashing Education Model for Patients," which was developed at the West Jersey Health System. The possible relevance of this poster to the vancomycin-resistant *Enterococcus* (VRE) control issue that was discussed at so many sessions was not lost on those who stopped to read it.
