# Notes on Contributors

Emile Chabal has been a Chancellor's Fellow at the University of Edinburgh since 2013. He completed his PhD in History at Cambridge in 2011 before going to Oxford as a Departmental Lecturer in Modern European History. In 2012 he returned to Cambridge as a Research Fellow in French Political History at St John's College; in the same year, his doctoral thesis was awarded the Prince Consort and Thirlwall Prize for the best history thesis at Cambridge. Emile's research has, for the most part, touched on three main areas: the transformation of French politics since the 1970s, Franco-British relations in the twentieth century and the legacy of postcolonialism in France. This has resulted in a number of publications, including a forthcoming monograph on contemporary French political culture, A Divided Republic: Nation, State and Citizenship in Contemporary France (Cambridge University Press, 2014) and a forthcoming edited volume, France since the 1970s: History, Politics and Memory in an Age of Uncertainty (Bloomsbury Academic, 2014). His future research plans include projects on late twentieth-century French liberalism, local politics in the Languedoc and post-war European intellectual life.

**Victoria Harris** is a Fellow at the University of Birmingham. Her research interests include the histories of sexuality, crime and deviance. She is the author of *Selling Sex in the Reich: Prostitutes in German Society, 1914–1945* (Oxford, 2010), which won the Women's History Network 2011 book prize and was a finalist for the Longman/History Today Book Prize, and 'Sex on the Margins: New Directions in the Historiography of Sexuality and Gender', *The Historical Journal*, 53, 4 (2010); as well as the English-language editor of *Letters to Hitler* (Polity, 2012). She is currently writing a book on the social history of intoxication in modern Germany.

**Alessandro Iandolo** is British Academy Postdoctoral Fellow in the Department of International History at the LSE. His main research interests are the history of Soviet foreign policy during the cold war, and the history of the communist movement in general. His publications include: 'The Rise and Fall of the Soviet Model of Development in West Africa, 1957–64', *Cold War History* (November 2012), and 'Imbalance of Power: The Soviet Union and the Congo Crisis, 1960–61', *The Journal of Cold War Studies* (forthcoming, winter 2014).

Anna Krylova is Associate Professor of Modern Russian History at Duke University. She works on twentieth-century Russia and the challenges posed in envisioning a socialist alternative in the age of industrial and post-industrial modernity and globalisation. Questions of historical theory, gender theory and practice in contemporary historical writing propel her work, with a special focus on historiographical problematics in western scholarship on the Soviet Union. She is the author of *Soviet Women in Combat: A History of Violence on the Eastern Front* (Cambridge University Press, 2010) which was awarded the 2011 Herbert Baxter Adams Prize of the American Historical Association. The book is an exploration of historical and theoretical ways of conceptualising heterosexual subjectivity, sexual difference and gender forms other than along opposition-bound imperatives. Her new project, 'Socialist Imaginaries of the Soviet century', aims to make possible a new cultural history of Soviet Russia by historicising the ways in which normative conceptions of socialist society, sociality and individuality evolved in Russia from the Revolution of 1905 to Gorbachev's half-decade of perestroika.

**Clifford Rosenberg** is Associate Professor of History at City College and the Graduate Center of the City University of New York. He has published *Policing Paris: The Origins of Modern Immigration Control* (Cornell University Press, 2006) and is currently at work on a project on the spread of tuberculosis between France and Algeria since the nineteenth century.

**Dennis Sweeney** is Associate Professor of History at the University of Alberta in Edmonton, Alberta, Canada. His first book, *Work, Race, and the Emergence of Radical Right Corporatism in Imperial Germany* (The University of Michigan Press, 2009), is a study of the transformation of factory culture and politics in the industrial Saar region and the emergence of a racialized corporatist ideology in Germany during the Wilhelmine period. His current book–length project, entitled *The German Right, Colonial Empire, and the Genealogy of the Racial State, 1891–1924*, is a study of radicalnationalist politics, bio–racism and plans for the creation of an authoritarian–populist 'racial state' as they were forged in the contexts of global capitalist expansion, interimperialist rivalry and German colonial rule during the late nineteenth and early twentieth centuries

**Tom Williams** is Wiener Anspach Foundation Postdoctoral Fellow at the Université Libre de Bruxelles. He is currently working on a history of wartime travel and soldiers' 'tourism' in Europe during the Second World War.

**Andrew Zimmerman** is Professor of History at the George Washington University. He is the author of *Anthropology and Antihumanism in Imperial Germany* (University of Chicago Press, 2001) and *Alabama in Africa: Booker T. Washington, the German Empire, and the Globalization of the New South* (Princeton University Press, 2010). He is currently working on a global history of the American Civil War, provisionally titled 'Slaves and Soldiers in the Red and Black Atlantic: A Transnational and Revolutionary History of the American Civil War'.



#### NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

#### Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Tara Zahra, tzahra@uchicago.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

- 1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
- 2. a 100-word summary of the article in English, French or German
- 3. a short title for use as a running page-head
- 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
- 5. a short biographical note with a description of work in progress and previously published work (130 words max.)
