

# Contributors

Robert D. Cuff was professor of history in the Faculty of Arts, and professor of policy at the Schulich School of Business, at York University in Ontario. Professor Cuff, who died this past November, was author of The War Industries Board: Business—Government Relations during World War I (1973), and coauthor of War and Society in North America (1971), Enterprise and National Development: Essays in Canadian Business and Economic History (1973), American Dollars/Canadian Prosperity: Canadian—American Economic Relations, 1945—1950 (1978), and other books. A list of his publications appears in this issue.

Pankaj Ghemawat is the Jaime and Josefina Chua Tiampo Professor of Business Administration at Harvard Business School. After receiving his Ph.D. in business economics from Harvard University, he worked as a consultant with McKinsey & Company in London during 1982 and 1983, and has taught at Harvard since then. Professor Ghemawat's publications include Commitment (1991), Games Businesses Play (1997), and Strategy and the Business Landscape (1999), as well as several dozen articles and case studies. He is coeditor of the Journal of Economics and Management Strategy, associate editor of Management Science, and member of the editorial board of the Strategic Management Journal.

David A. Kirsch is assistant professor of entrepreneurship at the Robert H. Smith School of Business at the University of Maryland, College Park. His research focuses on the intersection of problems of innovation and standardization, technological failure, and industry evolution. His first book, *The Electric Vehicle and the Burden of History* (2000), examines the history of the electric vehicle in the United States in the early twentieth century and the implications of that history for contemporary transportation policy.

Gijs Mom is assistant professor in the history of technology at the Technical University of Eindhoven, where he also serves as program coordinator for transport history at the Foundation for the History of Technology. Author of more than a dozen books on automotive technology, his study of the early history of the electric vehicle is due to be published by Johns Hopkins University Press this year. His current project is a two-volume handbook on the history of transportation and traffic

in nineteenth- and twentieth-century Netherlands, which he is writing with Ruud Filarski.

Robin Pearson is senior lecturer in economic and social history at the University of Hull, England. He received his Ph.D. from the University of Leeds in 1986. He has published widely on various aspects of British and international insurance history and has recently completed a book entitled *Insuring the Industrial Revolution: Fire Insurance and the British Economy*, 1700–1850. He is currently working on a book about the export of property insurance from Europe to the United States between 1850 and 1920 and a study of corporate governance in British business before 1844.
