ASSISTANT PROFESSORS

in the following specializations:

Terrorism Studies

Applicants are expected to be scholars whose research focus on the analysis of political violence and terrorism. They are also expected to be able to manage a team of research analysts, to provide research direction, conduct threat analysis, as well as write and vet papers on political violence and terrorism.

Maritime Security

Applicants are required to have a good understanding of contemporary maritime security issues in Asia Pacific and the Indian Ocean. They should have a sound understanding of maritime affairs, International Law of the Sea and some foundation in International Relations. He or she will have an interest in naval development, maritime strategy and some knowledge in international shipping will be desirable.

Northeast Asian Security / China

Applicants will have an interest and expertise in the domestic and external dynamics that impact on Chinese security and foreign policy. He or she will be expected to develop and teach courses on Chinese foreign/security policy and the international relations of East Asia in the School's M.Sc. programmes, organise and participate in conferences and seminars, and publish academic papers as well as policy relevant papers. The successful candidate is likely to hold a Ph.D. in international relations, political science, or history, with the dissertation or published work focusing on Chinese foreign/security policy. Proficiency in written and spoken Chinese is a must; experience in policy-relevant research and publication would be a major advantage. The successful candidate will also have the opportunity to play a major role in building the School's China Programme, which aims to be policy-relevant besides offering cutting edge research and quality teaching.

All successful candidates will be attached to the research centres of the school and will be expected to contribute to the centre's programmes and activities.

In addition to having the requisite research skills, successful applicants must also be prepared to teach up to two courses in the School's Master of Science Programmes. A relevant PhD and a good publication record are therefore essential requirements. Applicants are also expected to contribute to the School's research agenda, contribute to team research and policy-oriented projects, teach in short executive programmes, and organise conferences and seminars. Experience in policy-relevant research and publication would be useful. Those with the appropriate qualifications and experience may be appointed at the Associate Professor level. Initial appointments are for three years, which are renewable, subject to mutual agreement.

Applicants should submit the following:

- A detailed curriculum vitae
- Two published articles or writing samples
- A cover letter specifying how your qualifications match the job description
- The names, addresses, phone numbers and email contact details of at least three but not more than five referees

Screening of applicants will begin immediately and will continue until positions are filled.

Only shortlisted candidates will be notified.



Notes for contributors

Manuscripts

The Editors welcome submission of material for consideration as a main article or as a review article. The length required for main articles is 9–12,000 words, including footnotes, and longer submissions will not normally be reviewed. Review articles should be about 4,000 words and replies about 2,000 words. These are also sent to independent referees. The *Review* is a refereed journal, and contributors should allow time for the process of refereeing to take place. **It is the author's responsibility to provide the editors with an accurate total word count for all articles on submission.**

Prospective authors should submit their manuscripts by electronic mail (RISsub@st-andrews.ac.uk) or on disk. Submission of manuscripts is now also online via the website: <<http://mc.manuscriptcentral.com/ris>>. Detailed instructions for submitting your manuscript online can be found at the submission website by clicking on the Instructions and Forms link in the top right hand of the screen; and then clicking on the Online Submission Instructions for Authors icon on the following page.

Manuscripts should be typed on one side of the paper only with generous margins and should be double spaced throughout. An abstract of 100 words plus a short biographical note (appropriate for Notes on Contributors) should accompany the manuscript. To guarantee anonymity, authors should include a title page without their names, and remove any reference to themselves from the manuscript.

When an article has been accepted for publication, the author **must** send a copy of the final version by e-mail attachment or on computer disk (IBM compatible PC) giving details of the word processing software used, and also one hard copy typescript. **The Editors reserve the right not to accept articles not presented in the house style, details of which are given below.**

References and notes

These should be amalgamated and signalled serially within each article by superscript numerals. References and notes should be at the foot of each page. References should give full biographical details, including place of publication **and** publisher, at first mention. Thereafter the author's surname and a short title should be used (not *op. cit.*). A cross-reference to the original citation, e.g. '(see n.4 above)', may also be added if the short title reference is not immediately clear. The title of an article should appear in single inverted commas; the title of a book or journal should be underlined. Main words should be 'first-letter' capitalised in article and book titles.

References and notes should be typed in the form of the following examples:

Subheadings

Contributors are encouraged to include up to two levels of subheading in articles to provide 'signposts' for readers. They should be typed flush left with only the first word and any proper names capitalised.

General

First proofs may be read and corrected by contributors provided that they can give the editors a current address and can guarantee to return the corrected proofs, by airmail where appropriate, within three days of receiving them.

Authors of articles and review articles will receive twenty-five free offprints. Additional copies may be ordered on the form provided which must be returned at proof stage.

Contributors of accepted articles will be asked to assign their copyright, on certain conditions, to the British International Studies Association so that their interest may be safeguarded.
