It attempts to tighten the theory of generative semantics in order to make it empirically testable, and examines the results about speech acts in the tightened theory in two ways: first, it explores the range of illocutionary force which interrogative-and imperative-form sentences encode; and second, it compares the view of illocutionary force and perlocutionary effect in this linguistic theory with the thinking of analytic philosophers.

There is a pressing need for some model or conceptual framework in whose terms it is possible to represent everything that can be known about word meanings and sentence meanings and which can at the same time be integrated with a theory of the grammatical organization of sentences and the grammatical functions of words. One effort to provide such a model is the movement in modern linguistics that has come to be called generative semantics.

The book that Domenico Parisi and Francesco Antinucci have written identifies a version of the generative semantics model, developing it in its own terms and with no intellectual pre-requisites in either linguistics or formal logic. The authors have concentrated on making the notations intelligible, making the style of analysis familiar, and demonstrating the applicability of the model to a large number of semantic

Language and Context The Aquisition of Pragmatics

This volume establishes the connection between language and its natural context and integrates Piagetian cognitive development and language development, reaffirming the role of the semantic component of speech, the intent of the speaker, the speaker's knowledge of his listener, and social constraints in the development of languages. The author stresses the fact that all knowledge, including linguistic knowledge, is procedural in nature, also supporting throughout the book Piaget's claim that thought is essentially "internationalized action", all of which is ultimately derived from the infant's original efforts to do things in the world.

This book serves as an introductory text to syntactic analysis and syntactic theory. It treats a number of the "core" phenomena of English syntax and uses them to illustrate the relationship between description and theory. The approach taken is a struct syntactic one in that semantic considerations are ignored except insofar as they provide validation for an analysis arrived at on the basis of purely syntactic considerations. Particular emphasis is placed on the interrelationships between constraints on grammars and the learnability of languages.

English Quantifiers Logical Structure and Linguistic Variation Guy Carden
