This year Philadelphia's Franklin Institute is celebrating the 150th anniversary of its founding of promote technological research and industrial advancement. During the years covered by this comprehensive history, the Institute established itself as a major force in American technological development, becoming the most important organization in the field.

Philadelphia's Philosopher Mechanics presents the role of technology in nineteenth-century America in terms of the nature of progress, government controls or the lack thereof, the public welfare, economic independence, and the rise of specialization. The author explores the careers of major figures in that period of American science and argues that by the 1840's the solitary inventor had already been replaced in some fields by organized research efforts.

Illustrated with four self-contained photo essays, this book will be a worthy addition to the strong Johns Hopkins list of books on the history of American technology, the most recent of which, *Elmer Sperry: Inventor and Engineer*, by Thomas Parke Hughes, received three awards, including the Dexter Prize of the Society for the History of Technology.
