PHILOSOPHY OF SCIENCE

Typescript. Typescript, double-spaced, should be submitted (in triplicate) to Professor Robert E. Butts, Department of Philosophy, Talbot College, University of Western Ontario, London, Ontario, Canada N6A 3K7. Typescripts will not be returned unless return postage is prepaid by cheque, money order, International Reply Coupons or Canadian stamps. A bibliographical list of cited references beginning with the author's last name, initials, followed by the year of publication in parentheses, should be headed 'References' and placed on a separate sheet in alphabetical order. Simple citations should then be made by employing in the text, *rather than by footnote*, the reference list by citing author and year of publication, e.g., Jones (1958) or (Smith 1974, p. 46). A detailed guide to the new reference style appears in the March issue of each year. Discursive footnotes should be numbered consecutively throughout the typescript. *Typescript should not exceed thirty-five double-spaced pages. Longer essays will be returned to the author(s) to be cut to the acceptable maximum. A summary abstract of approximately 100 words should accompany each article.* All illustrations must be professionally drawn and lettered. All formulas and equations should be put in such a form as to help minimize the number of printed lines in the journal. In the following examples the form on the right is preferable to that on the left:

$$(2) \quad \frac{1}{x} \prod_{n=1}^{\infty} \frac{\left(1 + \frac{1}{v}\right)^n}{1 + \frac{x}{v}} \qquad 1/x \prod_{n=1}^{\infty} (1 + 1/v)^n / 1 + x/v$$

Copyright. Manuscripts should be submitted to *Philosophy of Science* with the understanding that upon publication copyright will be transferred to the Philosophy of Science Association.

Reprints. Contributors of articles to this journal will receive, gratis, 25 reprints. Authors desiring additional reprints may order them by sending in, with their corrected galleys, the special order forms which they will find enclosed with their galleys.

Reviews. Publications intended for review should be sent to Prof. William Demopoulos, at the address given above.

Philosophy of Science is published quarterly; issues are dated *March, June, September and December* of each year. Correspondence concerning business matters should be addressed to Peter D.
