



This dictionary, a basic reference tool in the study of Austronesian (formerly Malayo-Polynesian) languages, is the result of a mammoth project involving the collaboration of more than 100 Austronesian specialists. It provides truly comparable material in that all of the language data were collected in the field over the same three-year period (1986-1989). In the style of Buck's *Dictionary of Selected Synonyms in the Principal Indo-European Languages* (Chicago, 1949), it contains detailed annotations and is valuable not only to semanticists but also to anthropologists and sociologists. It is the first attempt since Buck's landmark work to provide a lexical reference work of similar scope on a language family in another part of the world.

The study of language contact has become an area of increasing attention and specialization within linguistics in recent years. Nevertheless, theoretical developments in the field have been hampered by the lack of a suitable range of readily available, well-documented cases. It is a principal purpose of this volume to attempt to meet the demand for more data by presenting a collection of cases from the Austronesian world.

It is linguistically one of the most diverse areas in the world, estimated to contain approximately one-quarter of the world's languages. Being an area composed of communities living on islands where generally more than one language is spoken, where extensive trading systems have developed, and where there have been and still are large movements of populations, it provides excellent opportunities for the study of language contact and change.

This book presents a new sub-discipline, *Morphopragmatics*, integrating morphology and pragmatics, which is focussed at grammatical (but non-prototypical) morphological phenomena such as diminutives, intensifiers and honorifics.

The authors claim that such regular morphological operations produce predictable pragmatic meanings that have so far failed to receive a systematic and explanatory treatment. They assert that this objective cannot be accomplished within semantics or general pragmatics and propose to this end a new theoretical model, a theory of morphopragmatics which deals with the area of systematic pragmatic meanings of morphological rules, i.e., of the regular pragmatic effects produced by them.

Through an analysis of repair mechanisms in English conversational discourse (both face-to-face and telephone) it aims to establish which contextual factors lead speakers to use certain anaphoric forms, and more specifically which factors determine the choice between a full lexical NP and a pronominal form. Since the choice between the two forms will depend to a large extent on the "anchoring" of the referential form in the discourse context, this study deals with the factors underlying certain types of discourse anaphora.

Contributions are welcomed from linguists in all countries, and not merely from members of the Linguistics Association of Great Britain. The normal language of publication is English.

Preparation of manuscripts Contributors should submit three copies of their manuscript. Submitted papers will normally be read by two referees. The name(s) of the author(s) should not appear on the paper itself and, as far as possible, the author(s) should not be identifiable from the references in the text or the acknowledgements. Details of name(s), affiliation(s) and full postal and e-mail address(es) should be submitted on a separate sheet. Fax and telephone numbers should also be included.

The manuscript of an article should be accompanied by an abstract of about 100 words summarising the content. The abstract will appear in the published version of a paper.

Manuscripts should be submitted on A4 paper (US 11"×8½") with margins of at least 4cm (1½") on all four sides of each sheet. They may be single-spaced and/or double-sided, if desired. However, the manuscripts of the final version of papers accepted for publication must be double-spaced and single-sided, with the type no smaller than 12 characters per inch (12pt) throughout the manuscript. One copy of the final version should be submitted.

Proofs First proofs only of articles, notes and discussion, review articles and book reviews, but not shorter notices, will be sent with the edited manuscript to the (first-named) author, who will be expected to correct them and return them to the Editors, within three days of receipt.

Offprints 50 offprints will be supplied free of charge to authors of articles, notes and discussion and review articles. 25 offprints will be supplied free of charge to authors of book reviews and shorter notices. Further offprints may be purchased if they are ordered at proof stage.
