DON DODSON, an Acting Assistant Professor of Communication at Stanford University, is a specialist in mass media and popular culture in Africa. His most recent publication is "The Role of the Publisher in Onitsha Market Literature" in Research in African Literature (Fall 1973).

ALAN P. MERRIAM is Professor, and former Chairman, of the Department of Anthropology, Indiana University. He is a specialist in the arts in anthropology, and has made a number of field trips to Africa, especially to the Republic of Zaire. His most recent book, An African World: The Basongye Village of Lupupa Ngye, will appear in the fall of 1974.

PAUL BRIETZKE is an Assistant Professor of Law at Haile Sellassie I University, having formerly taught at the University of Malawi. His interests include African criminal law and law and development.

- S. A. ONI is a Senior Lecturer in Agricultural Economics at the University of Ibadan, Nigeria. A specialist in production economics and agribusiness management, he has published considerably in academic journals on the economics of peasant cocoa production. His most recent article is "Estimating Supply Response via Producer Panel Approach: A Case Study of Western Nigerian Cocoa Farmers." published in Indian Journal of Agricultural Economics, (Vol. XXVII, No. 2).
- J. K. OLAYEMI is a Research Fellow in Agricultural Economics in the Nigerian Institute of Social and Economic Research, University of Ibadan, Nigeria. A specialist in Production Economics, he has published a number of articles on the economics of cocoa production in Nigeria one of the most recent being "Technology in the Western Nigerian Cocoa Industry: An Empirical Study" published in the Economic Bulletin of Ghana, (Vol. 2, No. 2).

RICHARD F. WEISFELDER is a visiting Assistant Professor of Political Science at Iowa State University. A specialist on the Southern African region, he has published several articles, chapters and monographs on the domestic politics and foreign relations of the Kingdom of Lesotho.

EUGENIA W. HERBERT has taught African history at Quinnipiac College and Yale University. A specialist in the economic history of the precolonial period, she is presently working on a study of the African copper trade and its cultural implications.

GARY WASSERMAN is an Assistant Professor of Politics at Medgar Evers College of the City University of New York. A student of Third World-industrialized states' relations and theories of imperialism, his not-yet published dissertation concerns the adaptation of Europeans to Kenya decolonization.

THOMAS W. LIVINGSTON is an Assistant Professor of Education at the University of California, Berkeley. A comparative educator concentrating

on Africa, his most recent book is <u>Education and Race: A Bibliography</u> of Edward W. Blyden, (Berkeley, Glendessary Press, 1974).

ALF ANDREW HEGGOY is an Associate Professor of History at the University of Georgia. He specializes in modern North African History and in French Imperial History. He has published two books, The African Policies of Gabriel Hanotaux (University of Georgia Press, 1972) and Insurgency and Counterinsurgency in Algeria (Indiana University Press, 1972) as well as numerous articles in a variety of journals. In 1974, he won two teaching awards at the University of Georgia: The Outstanding Honors' Professor Award and the Joseph H. Parks Award for Distinguished Teaching in History.

JAMES B. WOLF is an Associate Professor of History in the Division of Social Science at the University of Colorado at Denver. His research in the past has focused on East Africa, the most recent publication being "Asian and African Recruitment in the Kenya Police, 1920-1950" in The International Journal of African Historical Studies, VI, 3 (1973). He is currently beginning a comparative study of Afrikaner and Irish anti-imperialism in the late nineteenth and early twentieth centuries.

DAVID WILLIAM COHEN is an Associate Professor of History and the Director of the Program in Atlantic History and Culture at the Johns Hopkins University. Author of The Historical Tradition of Busoga: Mukama and Kintu (Clarendon, 1972), he is now completing a study of the pre-colonial history of Bunatu Village in Busoga, Uganda.
