There are those who purport that history is little more than the recording of the events in the lives of great men and women. If there is truth in this argument, then it follows that African and African-American history should, in some measure, be an accounting of the events in the lives of great men and women of African descent. *Pan-African Biography*, a new publication produced jointly by the African Studies Association and the African Studies Center, UCLA, adds to this accounting with essays about many great African and African-American men and women whose contributions to history have reached across Africa and it diaspora many times over; men and women who have provided a human dimension to the Pan-African fabric.

**Pan-African Biography** contains the proceedings of an interdisciplinary colloquium, "The Relevance of Pan-African Biography to the Study of African History," held in the Spring of 1982 at the University of California, Los Angeles. These essays survey the lives and times of many notable 'Pan-Africanists', including Conrad Rideout, Dusé Mohamed Ali, Chief Alfred Sam, J. Abayomi Cole, W.E.B. Du Bois, Ralph Bunche, Constance A. Cummings-John, Mbiyu Koinage and Andrée Blouin. And while these essays are not the last word on their subjects, they do serve to push back the boundaries of ignorance where the lives of African men and women are concerned.

Beyond Crisis: Development Issues in Uganda. Paul D. Wiebe and Cole P. Dodge, editors. 1987. Crossroads Press/ASA and Makerere Institute of Social Research. Softcover, 158 pp. \$15.00. ISBN 0-918456-60-6.

Political instability, social and physical insecurity, repression and violence have repeatedly surfaced in Uganda over the past several decades. Leader after leader has crossed the political stage, but no national consensus or sense of direction has yet emerged. The crises through which Uganda has passed in recent years have taken a terrible toll, including loss of life, displacement, collapse of the economic sector, and attacks on educational and religious institutions. Once referred to as the "pearl of Africa," Uganda was one of Africa's most developed countries at independence, but by the early 1980s Uganda has to be considered one of the world's "least developed countries."

Development issues abound in Uganda. New approaches are necessary in reference to food and nutrition, health, education, economic and other issues in Uganda. Social infrastructures will have to be rehabilitated. Much will have to be newly constructed. Priorities will have to be established. The achievement of all objectives will depend upon the active participation of the Ugandan people at all stages and levels in the determination of their life styles and life chances. But such, of course, is the essence of development.

Crossroads Press and the Makerere Institute of Social Research are privileged to introduce *Beyond Crisis: Development Issues in Uganda*, a new publication which examines prospects for the future in Uganda. The essays contained in this new book are largely drawn from a conference held at Mweya Lodge in southwestern Uganda in April 1986. The contributors were Ugandan or others with long-term Uganda experience and commitment.
