### THE CONTRIBUTORS

HAROLD SPROUT is Henry G. Bryant Professor of Geography and International Relations, and Faculty Associate of the Center of International Studies, at Princeton University. Co-author (with Margaret Sprout) of Foundations of International Politics (1962), he is currently at work on a study (again in collaboration with Margaret Sprout) of Britain's role in international politics.

MICHAEL BRECHER, Associate Professor of Political Science at McGill University, will spend the spring term of 1963 at the University of Chicago as Visiting Professor of Political Science. The author of Nehru: A Political Biography (1959), which was awarded the Watumull Prize of the American Historical Association in 1960, he has a volume of essays on The New States of Asia coming out next fall.

B. B. Schaffer, Reader in Public Administration at the University of Queensland, Brisbane, Australia, has worked with the U.K. Treasury, the Australian Public Service Board, and other authorities. He is finishing a comparative study of the machinery of government and co-editing (with D. C. Corbett) a casebook of Australian Commonwealth administrative decisions.

MARTIN KILSON is Lecturer in Government at Harvard University and Research Associate of Harvard's Center for International Affairs. A Ford Foundation Research Fellow in West Africa in 1959-1961, he recently completed a study entitled *Political Change in a West African State*.

James R. Schlesinger, Associate Professor of Economics at the University of Virginia, serves as a Consultant to The RAND Corporation and to the Board of Governors of the Federal Reserve System. His publications include *The Political Economy of National Security* (1960).

GEORGE A. LANYI, Professor of Government at Oberlin College, is engaged in a study of British foreign policy toward Germany in the period from 1933 to 1939.

DAVID H. BAYLEY is Assistant Professor of International Relations at the University of Denver. The author of *Preventive Detention in India: A Case Study in Democratic Social Control* (Calcutta 1962), he is preparing *Public Liberties in the New States*, to be published as a paperback in 1963.

CHARLES NEFF, Assistant Professor of Government at the University of Hawaii, serves as Coordinator of the World Affairs Section, Peace Corps Training Project, Hilo, Hawaii. He is working on a study of attitudes toward international affairs in Hawaii.

Nelson W. Polsby, Assistant Professor of Government at Wesleyan University, is the author of the forthcoming Community Power and Political Theory and co-editor of Politics and Social Life: An Introduction to Political Behavior, which also will appear this spring. He is making a long-term study of the politics of the House of Representatives.
