# INTERNATIONAL INSTITUTE ON AGING (UNITED NATIONS — MALTA)

In order to help developing countries prepare for the inevitable consequences of a dramatic increase in their elderly populations, the International Institute on Aging (INIA) was established in 1987 as an autonomous body under the auspices of the United Nations. The main objectives of INIA are to fulfil the training needs of developing countries and to facilitate in a practical way the implementation of The Vienna International Plan of Action on Aging (adopted by the 1982 World Assembly on Aging).

#### Training programme

INIA conducts three short-term courses annually; Social Gerontology, Income Security for the Elderly in Developing Countries and Medical Geriatrics; plus a long-term postgraduate course in Gerontology (in conjunction with the University of Malta). To date, a total of 176 candidates from a wide range of developing countries (primarily sponsored by UNDP and UNFPA) have participated in INIA's training programmes.

#### International activities

A Collaborating Network of 102 organizations from 50 countries are able to exchange information through the UN Electronic Information Network and UNICEF field offices.

Collaborative Agreements: INIA has developed arrangements for active and close co-operation with 24 UN specialized agencies and other organizations.

#### Research

INIA is collaborating with the WHO Programme for Research on Aging on a study of 'Age-associated dementias'.

A consultancy mission by INIA in China in June 1990 resulted in the formulation of a four-year research project on 'The implications of the aging population on the support systems for the elderly in both urban and rural China'.

#### **Publications**

A quarterly gerontological journal BOLD; Proceedings of the Expert Group Meetings for the design of the curricula for the four training courses; 16 country monographs on population aging in a joint project with CICRED (France). Video-tapes of INIA's training courses are also available.
