CANADIAN ASSOCIATION OF HISPANISTS, Annual Meeting. Winnipeg, Manitoba. June 4–5, 1970.

The Humanities Research Council of Canada sponsored the meeting held at the University of Manitoba. J. H. Parker, President of the University of Toronto, organized the

At the conference it was resolved that specific study of Latin America is the responsibility of the new Canadian Association of Latin American Studies, organized in June, 1969, at York University, Toronto (Viz. "Institutional News").

COMMUNITY DEVELOPMENT, 1st Inter-American Conference on. Santiago, Chile. July 20–26, 1970. The Organization of American States was the sponsor of this first Inter-American Conference on Community Development. The agenda consisted of three major topics: 1.

Community Development, Popular Participation, and Overall Development; 2. Review of Community Development in Latin America: National Programs, External Assistance—Public and Private; 3. Measures to Strengthen Community Development in Latin America: Internal Effort, External Assistance, Measures for Immediate Action at the Inter-American Level. The participants were delegations from fifteen member countries of the OAS: Venezuela, Ecuador, República Dominicana, Brasil, United

States, Bolivia, Colombia, Perú, Panamá, Nicaragua, Costa Rica, Argentina, México, Uruguay, Chile. There were observers from twelve non-member countries, and from inter-American and international inter-governmental organizations, including the United Nations, and national and international non-governmental organizations.

At the conclusion of the meeting, the Conference issued the "Declaration of Santiago," which laid out the basis of the concept of community development. It stressed that community development should not be conceived of only as an instrument at the service of economic growth. Rather, it is a comprehensive process of social and cultural and economic change. The principles and recommendations made in the Declaration covered: internal effort; external assistance; and measures for immediate action at the inter-American level. The next meeting will be held in Lima, Perú, in 1973.

INSTITUTION BUILDING, Regional Conference on. Utah State University, Logan, Utah. August 17–21, 1970. The Regional Conference served as a confrontation between academic and field staff on the subject of institution building, as well as a meeting between the donors and the recip-

ients of American Foreign Assistance. Bruce H. Anderson and J. Clark Ballard organized the conference under the sponsorship of the Utah International Educational Consortium and the United States Agency for International Development. The participants included academic and administrative representatives of universities throughout western United States, administrative and field personnel from the USAID, and several Latin Americans from academia, industry, and government agencies.

The conference dealt with concepts of institution building and their adaptation to practical work situations in the field. Case studies taken from Latin America were the following:

Recommendations were made to promote similar conferences throughout Latin America. These regional meetings would aim at a greater involvement of Latin Americans, especially the young scholars among them, and their AID counterparts, under OAS sponsorship. The Proceedings of the Conference, including speeches and abstracts of the presentations, were published by the Utah International Education Consortium early in 1971.
