This series begins on the premise that the past two decades have seen fascinating and controversial changes in the biological sciences. One thinks of methods for analyzing the basic molecular units of heredity; of proposals and clarifications of the appropriate methods of classifying organisms; of new ideas about the nature of the fossil record and evolutionary mechanisms; and of ways in which the biological study of behavior has been extended that include implications for humans, especially language behavior.

In addition to these internal issues, there are important debates about biology in relation to such diverse areas as education and conservation. Such issues have made biology one of the more exhilarating of the contemporary sciences, and have stimulated biologists and philosophers to critically investigate both the nature of biology (methodology and epistemology) and its social implications. There has been more recent activity in the philosophy of biology than at any other time since the philosophical debates following the publication of Charles Darwin's *Origin of Species* in 1859.

The series is aimed at a broad readership, drawn from both the sciences and humanities. It subscribes to no specific school of biology or philosophy, welcoming submissions from authors of all persuasions and all disciplines.

It is hoped that within the bounds of this series, philosophical essays can be published as companions to existing influential monographs in Biology. The series editor wishes to bring to print research that illuminates issues common to the biological sciences and philosophy—the philosophy of mind, epistemology, methodology, and ethics—in important new ways.

THE PHILOSOPHY OF SCIENCE ASSOCIATION

The Philosophy of Science Association is an international society dedicated to the furthering of studies and free discussion from diverse standpoints in the field of philosophy of science. To promote these objectives, the Association: holds biennial conferences and arranges for the publication of the proceedings of these conferences; publishes the quarterly journal, *Philosophy of Science*, which carries essays, discussion articles, and book reviews in the general area of philosophy of science; publishes the *Association Newsletter* which provides a channel for communication of such information as grants, jobs available, recent appointments, conferences, new periodicals and bibliographic notes; is an affiliated society of Section L of the American Association for the Advancement of Science; selects two representatives to serve on the National Academy of Sciences U.S. National Committee for the International Union for the History and Philosophy of Science; and is one of the national members of the International Philosophy of Science Association.

The Association is a non-profit corporation formed under the laws of the State of Michigan. It currently enjoys tax-exempt status under the U.S. Internal Revenue Code and contributions to the Association are U.S. tax deductible. The affairs of the Association are controlled by a Governing Board which is composed of the President of the Association, the President elect, the most recent Past-President, and eight members elected at large.

To supervise the various functions of the Association the Governing Board appoints individuals to serve as Executive Secretary of the Association, Editor-in-Chief of *Philosophy of Science*, Editor-in-Chief of the *PSA Newsletter*, and Editor-in-Chief of the *PSA Proceedings*.

Membership is available to all individuals who agree to the objectives of the Association as stated above and who also agree to reserve their copies of the journal for their personal use only. There are three classes of membership in the Association: full, associate, and student. Prima facie eligibility for *full membership*, is demonstrated by: 1) holding a Ph.D., D. Sci., or M.D. degree (or equivalent) in philosophy, science or a science related field. To be eligible for *associate membership*, one must simply be in agreement with the objectives of the Association. To be eligible for *student membership*, one must be a full-time student at an accredited institution of learning. Payment of annual dues entitles all members to receive the journal, *Philosophy of Science*, and the *Association Newsletter* at no charge. Reduced registration fees are also charged to members for the biennial meetings. Full members are entitled to hold office and vote in the Association's annual election of Governing Board members.

For 1988 the dues are \$35.00 for full and associate members and \$18.00 for student members. Memberships start at the beginning of a calendar year. Members who join during the course of the year will be sent back copies of all material for that year.
