



A Tale of Two Policies is a case study of one of the oldest policy dilemmas for the United States in the Third World — how to fashion policy towards non-democratic regimes that is both effective and morally satisfying. In the Argentine case, Mark Falcoff surprisingly concludes that, different as were the approaches of the Carter and Reagan people towards this problem, both administrations pursued policies irrelevant to the developments in that country. The analysis, grounded in a mastery of the political cultures of Argentina and two U.S. administrations, is a product of FPRI's threeyear project on Friendly Tyrants, a comparative study of U.S. relations with pro-American regimes in the postwar era.

Mr. Falcoff is Resident Scholar in Foreign Policy at the American Enterprise Institute for Public Policy Research, Washington, D.C., and author of *Modern Chile*, 1970-1989 (Transaction).
