



The rule of law, peace, disarmament, human rights: these are no longer empty words, but legal concepts steadily gaining force among nations. If the slow but sure codification of international law has put down roots, it is because of the passionate determination of a few visionary but practical actors on the world's stage. Pre-eminent among these 'workers in the dawn' was the Russian jurist, diplomat and arbitrator F.F. Martens (1845-1909). This English translation of the first major biography of Martens is in fact the most complete text in any language, as the Russian author, at the translator's request, took the opportunity to revise his original work and even supplied two whole chapters missing from the original Russian edition of 1993 and subsequent editions and translations. ### MASCULINITIES, SEXUALITIES AND CHILD SEXUAL ABUSE

by Anne Cossins

Why is child sexual abuse committed primarily by men and male adolescents, unlike other forms of child abuse? Is child sex offending, rather than being a deviant masculine sexual practice, related to normative masculine practices, that is, practices structured on dynamic and changing relations of power? Using a practice-based sociological approach, the relationship between masculinities, sexualities and child sexual abuse is analysed and the power/powerlessness theory is developed to explain the predominantly male problem of child sex offending. The book argues that an offender's experiences of powerlessness as a result of his relationships with other men is the key to understanding child sex offending, since sexuality is a key social practice for the alleviation of experiences of powerlessness and for establishing relations of power with other men. In the final chapter, the theory is tested through a re-analysis of offender interviews.

The euphoric cries of a peaceful and more dynamic 'new world order,' which followed the end of the Cold War have been silenced by the increased intensity of local conflicts around the world. The humanitarian crises resulting from these conflicts have attracted greater international attention. Perhaps even more tragic is the failure of the international community to find early effective response to these conflicts, which have profound security implications for the affected regions and have led to the collapse of state structures in some cases. This book reconsiders the role of the UN and regional organisations such as ECOWAS in Africa. It examines the response to the civil war in Liberia, which served as a precursor to the international response to the crisis in Sierra Leone. It both offers an analysis of a new conceptual framework for managing a specific class of violent conflict, and provides first hand account of the character of a force that attempted to apply this approach.
