Director of Government Relations, Public Engagement, and Congressional Fellowship Programs

Kara Abramson joined APSA in August as director of government relations, public engagement, and congressional fellowship programs. Betsy Super has been appointed as the senior director of research and development. Betsy oversees research support programs for ASPA members including the Centenni-

al Center for Political Science and Public Affairs, small research grants, travel grants, and the ethics program. She also leads the association's research on the profession, and individual and institutional development.
