Donald S. Lopez, Jr.

The *Heart Sutra* is perhaps the most famous Buddhist text, traditionally regarded as a potent expression of emptiness and of the Buddha's perfect wisdom. This brief, seemingly simple work was the subject of more commentaries in Asia than any other sutra. In *Elaborations on Emptiness*, Donald Lopez explores for the first time the elaborate philosophical and ritual uses of the *Heart Sutra* in India, Tibet, and the West.

Included here are full translations of the eight extant Indian commentaries. Interspersed with the translations are six essays that examine the unusual roles the *Heart Sutra* has played. *Elaborations on Emptiness* demonstrates why commentary is as central to modern scholarship on Buddhism as it was for ancient Buddhists.

The *Wen xuan* is the oldest surviving anthology of Chinese literature arranged by genre. It contains a total of 761 pieces of prose and verse by 130 writers from the late Zhou dynasty to the Liang dynasty.

This anthology was one of the primary sources of literary knowledge for educated Chinese in the premodern period, and it is still an essential work for specialists in classical Chinese literature. This volume completes the translation of the rhapsodies (chapters 13 through 19) and includes many important masterpieces of early Chinese literature.

Article manuscripts, including notes, should not exceed 40 pages in length. Please submit four copies and a disk (preferably formatted to WordPerfect 5.1). All submitted work should be double-spaced, including extracts, notes, and references. Consult recent issues of the *Journal* as a guide to format. Footnotes should be as few as possible, and typed double-spaced at the end of the text. Documentation should follow the style recommended in sections 16.3 through 16.28 of the *Chicago Manual of Style*, 14th ed. (Chicago: University of Chicago Press, 1993), pp. 641–51. Authors are encouraged to submit tables, figures, maps, photographs, and other illustrations along with their manuscripts; please consult the editor for specifications. Additional guidelines on manuscript preparation will be sent upon request.

All manuscripts submitted to the *JAS* are expected not to have been published elsewhere and not be under review for possible publication elsewhere. Unsolicited book reviews are not accepted.
