An interim solution is needed urgently because the status quo is dangerous and unstable, because of unilateral actions by the claimants and continuing opportunities for involvement by outside powers. A regional multinational solution for part of the area is proposed because other alternatives do not appear to be practical. The creation of a regional multilateral resource management body has the potential to reduce the tension currently rife in the region. This book should be helpful to decision-makers, negotiators, and academics desirous of a peaceful solution to these disputes.

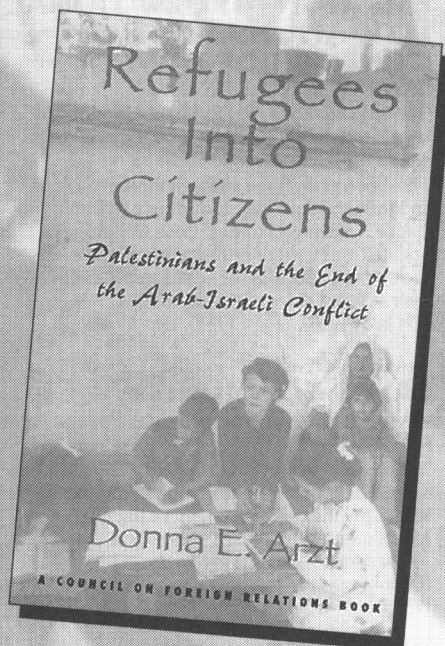

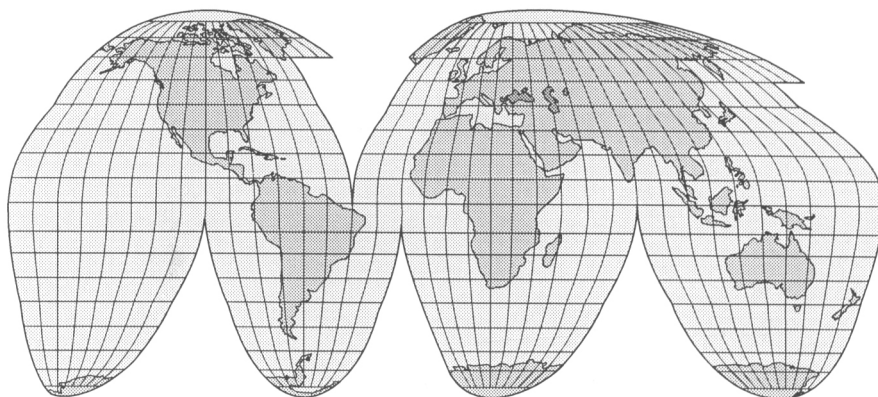

Akehurst's Modern Introduction to International Law

"Professor Malanczuk has written a new edition of Michael Akehurst's textbook which maintains its high traditions of clarity, precision and coherence.
