## Notes on Contributors

Lauren N. Faulkner teaches history at Notre Dame University. She is currently revising her dissertation, completed in April 2009, which is a study of the Catholic military chaplaincy between 1939 and 1945, as well as a detailed investigation of the wartime experiences of conscripted German Catholic priests and seminarians during the Second World War.

Marc Landry is currently pursuing a Ph.D. in history at Georgetown University. His research interests are German, European, and global environmental history. His dissertation is on the incorporation of Alpine hydroelectricity or 'white coal' into the European energy system.

Eldrid I. Mageli is a historian and researcher at the University of Oslo, Department of Archaeology, Conservation and History. She has written on Indian contemporary history, focusing on social and political activism in Chennai and Kolkata: *Organising Women's Protest. A Study of Political Styles in Two South Indian Activist Groups* (1997); 'NGO Activism in Calcutta 1973–1997: Exploring Unnayan', Ph.D. thesis, 2001; and Norwegian–Japanese relations: *Towards Friendship: The Relationship between Norway and Japan*, 1905–2005 (2006). She is currently writing a book on the history of the Norwegian Red Cross, 1865–2015.

Lenka Nahodilova trained as a social and medical anthropologist. Her research interests lie in the nineteenth- and twentieth-century history of eastern Europe and the Balkans. She has conducted research on Muslim minorities in Russia, the former Yugoslavia and Bulgaria. She obtained her Ph.D. at Charles University Prague and currently teaches at the School of Slavonic and East European Studies, University College London.

Mark Roseman is Pat M. Glazer Chair of Jewish Studies and Professor of History at Indiana University. He is author of several books on the Holocaust and on modern German history, including *The Villa, the Lake, the Meeting* (2002), *The Past in Hiding* (2000) and, most recently, with Jürgen Matthäus, *Documenting Life and Destruction: Jewish Responses to Persecution, 1933–1946, Volume I (1933–1938)*) (forthcoming). Recent edited collections include *Conflict, Catastrophe and Continuity: Essays on Modern*

German History (2007, with Frank Biess and Hanna Schissler) and German History from the Margins (2006, with Neil Gregor and Nils Roemer). He is currently working on a history of the life-reform group 'Bund. Gemeinschaft für sozialistisches Leben', and on a book about Nazi perpetrators.

Ian D. Thatcher is Professor in History at the University of Ulster, Coleraine. He has published widely on the Russian revolution, including *Trotsky* (2003), *Late Imperial Russia: Problems and Prospects* (2005), and *Reinterpreting Revolutionary Russia* (2006).

Gregor Thum is a research fellow at the Freiburg Institute for Advanced Studies. He taught modern central European history at the University of Pittsburgh and the European University Viadrina in Frankfurt (Oder). His first book – *Die fremde Stadt. Breslau 1945* (2003) – examines the transformation of German Breslau into Polish Wrocław after the Second World War. Currently, he is working on a book entitled *Mastering the East: The German Frontier from 1800 to the Present.*



#### NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

#### Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be referred.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

- 1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
- 2. a 100-word summary of the article in English, French or German
- 3. a short title for use as a running page-head
- 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
- 5. a short description of work in progress and previously published work
