# **Immigrants and Associations**

The essays collected in this volume are all concerned with one particular and recurring source of cultural diversity, the culturally alien community resulting from migration in pursuit of economic opportunity. The essays by Freedman, Tsien and Topley describe two communities resulting from the Chinese diaspora – those of Singapore and Madagascar. Winder's essay concerns the settlement in West Africa of another widely ranging emigrant group, the Lebanese. While the case described by Morrill is somewhat different in that it does not involve international migration, the results are broadly similar: the Ibo, like the Efik among whom they have settled, are Nigerians but the two groups are sufficiently different culturally that the Ibo may be regarded, and seem to regard themselves, as 'strangers' in Calabar. We have, then, a series of case-studies of economically differentiated stranger communities.

The authors of the essays focus most of their attention upon the internal organization of the immigrant communities – upon the institutions developed by them for the purpose of coping with a new and hostile environment. Both socio-economic considerations, and political (colonial and post-colonial) situations, are treated by the contributors to this volume.
