Insomnia Clinic

The Bethlem & Maudsley Trust and Institute of Psychiatry have opened the UK's first clinic for the treatment of insomnia in elderly people. It will be free of charge and will focus on behavioural techniques that improve sleep habits without medication. The Maudsley's Insomnia Clinic for Elderly People is an outpatient service which is open to anyone over the age of 65 years with a referral from their GP.

Mental health management award

The Wessex Project, a collaborative project involving professionals from health, probation, prison and social services sectors, has won the 1994 Graham Day Award. The national award, organised by Newcastle City Health NHS Trust, was established with the aim of recognising effective management of mental health services. The panel of judges included retired industrialist Sir Graham Day and chose the innovative project for the £5,000 top award.
