- Joseph Cropsey received his undergraduate and graduate degrees from Columbia University. He taught economics at the City College of the College of the City of New York and philosophy at the New School for Social Research before joining the Political Science Department of the University of Chicago. His subject is the history of political philosophy, concentrating on Greek antiquity and the modern period from the sixteenth to the twentieth century. His writings have been on the history of thought and the bearing of thought on politics.
- Alan Gilbert teaches at the Graduate School of International Studies of the University of Denver. He received a Ph.D. in Government from Harvard and has done advanced work in philosophy at Cornell. He is the author of *Marx's Politics: Communists and Citizens* and of articles on ethics and social theory in *The American Political Science Review, Philosophy and Public Affairs, Political Theory, The Occasional Review, and Nomos.* He is currently completing a book on *Equality and Objectivity*.
- Richard Miller teaches in the Department of Philosophy at Cornell University, where he is an Associate Professor. His many writings in ethics, political philosophy and the philosophy of science include, most recently, *Analyzing Marx* (Princeton University Press, 1984) and "Ways of Moral Learning" (*Philosophical Review*, October 1985). He has just completed a book in the philosophy of science, *Fact and Method: Explanation and Confirmation in the Natural and the Social Sciences*.
- G. A. Cohen was born in 1941 in Montreal, where, at McGill University, he obtained his B.A., in Philosophy and Politics, in 1961. He then read for the B. Phil. in Philosophy at New College, Oxford, and from 1963 to 1984 he taught in the Philosophy Department of University College London. He became Chichele Professor of Social and Political Theory and Fellow of All Souls, Oxford, in January 1985. He is the author of *Karl Marx's Theory of History: A Defense* (Princeton and Oxford, 1978), and of articles in philosophical and social scientific journals.
- Jon Elster is a Professor of Political Science at the University of Chicago and Research Director at the Institute for Social Research, Oslo. Among his publications are: Leibniz et la Formation de l'Esprit Capitaliste (1975), Logic and Society (1978), Ulysses and the Sirens (1979), Explaining Technical

*Change* (1983), *Sour Grapes* (1983), and *Making Sense of Marx* (1985). He is currently working on problems in the intersection of bargaining theory, the theory of collective action, and the theory of distributive justice.

- Allen Buchanan received a B.A. from Columbia University in 1970 and a Ph.D. in Philosophy from the University of North Carolina in 1975. He has taught at the University of Minnesota, served as staff Philosopher to the President's Commission for the Study of Ethical Issues in Medicine and Biomedical and Behavioral Research, and is currently Professor of Philosophy at the University of Arizona at Tucson. Buchanan has published numerous articles in social and political philosophy, ethics, medical ethics, and epistemology, and is the author of two books: *Marx and Justice: The Radical Critique of Liberalism* (1982) and *Ethics, Efficiency and the Market* (1984). He is currently at work on a book in medical ethics on decisionmaking for incompetent patients.
- David Gordon received his Ph.D. from U.C.L.A. He is currently completing a book on individualist political theory. He has written articles on this topic, as well as others, including skepticism, utilitarianism, John Stuart Mill's views on morality-dependent harm, and the generalization argument in ethics. Articles by him have appeared in Analysis, British Journal of Political Science, Canadian Journal of Philosophy, Ethics, Journal of Value Inquiry, Mind, Political Studies, Politics, Religious Studies, and other journals.
- John Gray, M.A., D. Phil, Oxon., was educated at Exeter College, Oxford, where he read Philosophy, Politics, and Economics. Since 1976 he has been Official Fellow at Jesus College, Oxford. In 1984, he was appointed Distinguished Research Fellow at the Center for Social Philosophy and Policy, and in Spring 1986 he was Visiting Professor in the Department of Government at Harvard. His books include: *Mill on Liberty: a Defense* (1983), *Hayek on Liberty* (1984), *Conceptions of Liberty in Political Philosophy* (co-edited with Z. A. Pelczynski, 1984) and *Liberalism* (1985). He is presently at work on a critique of Marxism.
- George Friedman received his B.A. from The City College of New York and his Ph.D. from Cornell University's Government Department. He is currently Associate Professor and Chairman of Political Science at Dickinson College, and is the author of *The Political Philosophy of the Frankfurt School*, published by Cornell University Press. He has written several other articles on Marx and Marxism and is completing a book entitled *Marxism and Judaism*.
