### CONTRIBUTORS

Estelle Joubert is Assistant Professor of Musicology with a cross-appointment in European Studies at Dalhousie University. Her research focuses on opera and political theory, and she has published articles in *Eighteenth-Century Music*, *Plainsong and Medieval Music* and *Musica e Storia* and a chapter on German opera in the *Cambridge Companion to Eighteenth-Century Opera* (Cambridge University Press, 2009).

Delphine Mordey completed her Ph.D. in historical musicology at King's College, Cambridge, before taking up a Junior Research Fellowship at Newnham College, Cambridge. She is currently a Bye-Fellow of Newnham, and Director of Studies in Music both there and at Churchill College, Cambridge.

Francesca Vella studied DAMS (Disciplines of Arts, Music and Drama) at the University of Florence, and piano and chamber music at the Scuola di Musica di Fiesole. She is currently writing her Ph.D. thesis at King's College, London on the figure of Verdi and the reception of his operas in Italy, particularly Milan, during the 1860s and 1870s.

Jed Wentz founded the early music ensemble Musica ad Rhenum, with which, as flautist and conductor, he has made more than thirty recordings of eighteenth-century repertoire. He teaches at the Conservatorium van Amsterdam and has published articles on music and dance in Tijdschrift voor Oude Muziek, Early Music, Journal for Eighteenth-Century Studies, The Eighteenth-Century Novel, Cambridge Opera Journal and Music in Art.
