



David Keen argues that famines, such as that which devastated the Dinka of Sudan in the 1980s, often have powerful beneficiaries within the affected nation. At the same time, shortcomings in the manner of international intervention, while contributing to famine, may offer significant political and bureaucratic benefits for international donors. Drawing on a range of historical information and the accounts of famine sufferers, aid providers, and government officials, Keen explains the causes of the Sudanese famine, extracting vital lessons about the future of famine relief.
