Dr. Calderwood spoke to ICHE about his artwork.

What was the inspiration for this artwork? Over the years, there have been many campaigns to improve hand hygiene in health care facilities (e.g., "Clean Hands Save Lives," "My Health is in Your Hands," "Speak up for Clean Hands"). During the past few years, though, the concept of the hand has taken on other meanings, as those in the healthcare community have lent a hand across a myriad of settings, have held the hand of patients, family, friends, and fellow healthcare workers who were suffering, and have stood hand-in-hand in facing the unknown, overcoming obstacles, and navigating the path forward. A hand held in an upward position, as shown in the painting, is also a means of saying "stop" or more specifically "prevent" as written on the palm. Whether it be in areas of HAI prevention, antimicrobial stewardship, outbreak investigation, diagnostic stewardship, or one of the many other topics covered within the pages of ICHE, the idea of prevention is one where safe and effective patient care is front and center in everything that we do.
