

The British Institute of Archaeology at Ankara was founded in 1948 and exists to undertake, promote and encourage British research into archaeology and related subjects in Turkey and surrounding regions such as the Black Sea littoral.

A small staff at the Institute's premises in Ankara, headed by Dr Roger Matthews as Director, conduct their own research, assist scholars, and maintain the Library and the research collections. The premises in Ankara are a centre for research and house a library of approximately 50,000 volumes. The research collections of archaeobotanical, epigraphic and pottery material, together with a laboratory and computer services, are available free of charge to members of the Institute. The Institute is able to offer to members, for a reasonable charge, the use of accommodation, surveying and photographic equipment, and vehicles.

Seventeen excavations and surveys, as well as museum-based research and publication projects, are currently sponsored by the Institute. Excavations presently supported include those at the Neolithic site of Çatalhöyük directed by Ian Hodder of the University of Cambridge, and at Pichvnari in the Republic of Georgia directed by Michael Vickers of the Ashmolean Museum and Amiran Kakhidze of Batumi Archaeological Museum. Surveys range from the multi-period Project Paphlagonia directed by Roger Matthews of the BIAA, to the investigation of the Iron Age city of Kerkenes Dağ by Geoff Summers of the Middle East Technical University, to the study of the Byzantine Anastasian Wall and associated features conducted by Jim Crow of the University of Newcastle upon Tyne.

Subscription to the Institute costs £25 per annum (£15 for students and those who are unwaged) payable by cheque in £Sterling or US\$. Members are entitled to copies of the Institute's journal, *Anatolian Studies*, and of its annual publication on current research, *Anatolian Archaeology*, a discount on other Institute publications, notification of conferences and lectures, and access to the library, accommodation and other facilities in Ankara.

### Oliver Gurney Editor 1956-1997

The name of Oliver Gurney is inseparable from Anatolian Studies. Already in volume 1 (1951) it appears in the list of the Council of Management for 1950 as representative of the University of Oxford. His uncle John Garstang had drawn him into Hittite studies, in which he completed his doctoral thesis in 1939, and, after his service in the war, he was appointed Shillito Reader in Assyriology at Oxford in 1945. Garstang founded the Institute in 1948, it was natural for Oliver to become involved in the new project. His name already appears as Assistant Editor of Anatolian Studies (under the Editor, Gordon Childe) in the Council of Management 1951, and when Childe departed for Australia in 1956, Oliver succeeded him as Editor. The first volume for which he was fully responsible was Anatolian Studies 6, planned as a Festschrift but sadly a memorial volume for Garstang.


Since then Oliver's editorship of the journal has spanned five decades of the development of the Institute. With his last volume, 47 (1997), to which he also contributed a typical and important Hittite article, he has seen through press a total of forty one volumes, having missed only volume 30, dedicated to him in honour of his 70th birthday and edited by James Macqueen. This surely must be something of a record, and the moment

for the heartiest congratulations. As all contributors will recognise, his involvement with every article has been deep and meticulous, and there can be few that have not benefited substantially from his wisdom and expertise. He has himself been a regular contributor, publishing in early volumes the Sultantepe tablets in a masterly series of articles, and more latterly various papers as demanded by the occasion.

Not content with regular labours of editorship, he has willingly undertaken even more demanding service: when the question of preparing an Index to volumes 21-30 was being discussed in Council, with particular reference to the likely costs, he volunteered to produce it himself, which he duly did after mastering the then newly available computer technology for the task.

With this volume of *Anatolian Studies* Oliver has handed over the baton (which of course accounts for its very late appearance). It is in the nature of things that the editorial burden which has been shouldered by him alone for more than forty years has to be divided between an editorial committee. But we much hope that he will continue for many years to keep a benevolent but perhaps not uncritical eye on the efforts of his successors.
