# CURRENT RESEARCH INVENTORY

THE CURRENT RESEARCH INVENTORY SECTION LISTS RESEARCH ON LATIN America, Spain, and Portugal, currently underway in the United States, Latin America, and Canada.\* The purpose of this section is to acquaint researchers working in the Latin American area with the various social science projects *currently* being carried out in the field. (Published research is not listed.) It is hoped that the information will provide an impetus toward communication among scholars concerning their own work and reduce duplication.

The projects listed in the following section of this issue include projects being carried out by researchers at institutions in the Eastern region of the United States and Puerto Rico, and projects being carried out by members of U.S. government agencies and international organizations. In the next issue, the Summer issue, projects being carried out by researchers from institutions in the Middle West and from those in the northern tier of Latin America (the Caribbean area, Central America, Mexico, Venezuela, and Colombia) will be listed. Projects underway in the Far West, Canada, and the southern tier of Latin America (Argentina, Bolivia, Brazil, Chile, Ecuador, Paraguay, Peru, and Uruguay) will be listed in the Fall issue.

The projects are arranged alphabetically according to institutions under three main classifications—United States Institutions, Canadian Institutions,





With respect to regional articulation, many communities show a marked upward shift and the whole regional structure has moved from a "primate" to a more heirarchical pattern, but commercial differentiation, a second dimension of growth, shows only internal shifting of rank. A structural-symbolic explanation for these changes is proposed and tested by correlating the 1950 values of the explanatory values with the degree of change during the 1950-1966 period. Las actitudes comprenden su grado de satisfacción en la docencia, actitud al cambio y adopción de nuevas formas metodológicas, actitud hacia los métodos de enseñanza, incluyendo los exámenes. El instrumento que ha sido contestado por cerca de 350 de profesores incluye tambien un inventario sobre métodos de enseñanza, materiales educativos, concimientos sobre evaluación de la enseñanza y el aprendizaje, motivación profesora, necesidades sentidas por los profesores, factors que retardan la adopción de un programa de investigación a nivel de facultades y medidas que debieran adoptarse para el establecimiento de tales programas. La información se ha recolectado en forma escalonada aprovechando de la realizacion de cursillo cortos intensivos sobre Metodología de la Enseñanza Superior en Ciencias Agrícolas. Actualmente los datos se encuentran en la

fase de crítica análisis y tabulación. Un informe final se espera publicarlo en el transcurso del proximo año 1969.

Physical and Socio-Economic Resource Inventory and Evaluation. (Ecuador)

An attempt to develop a methodology for the evaluation of natural resources to program and carry out agrarian reform and colonization projects with particular reference to the Cayambe project in Ecuador. Study will involve the following steps: determination of objectives; collecting of data about the natural resources; determination of potential land use; social and economic studies; programming land use; physical planning and rural architecture; and financing of the project. Begun, 1968. EDC, 1969. A related work recently published by IICA is Agricultural Regionalization and Programming in the Nicoya-Puerto Jesús Area, Guanacaste Province, Costa Rica.
