- 3. Articles should normally be 5–7500 words in length, including notes, though longer articles may sometimes be considered.
- 4. All contributions should have an abstract (150–200 words) and 5 keywords describing the contents of the article, for web searching purposes.
- 5. Contributions should be submitted, typed double-spaced on one side of the paper, or preferably as e-mail attachment to nb.editor@english.op.org.
- 6. Greek and Hebrew etc., should be transliterated.
- 7. Notes (preferably footnotes) should be numbered sequentially throughout the article.
- 8. Submissions may follow either UK or US spelling conventions, provided that they are consistent.
