Contributors are strongly advised to prepare their typescripts in the manner set out in the *Instructions to Authors* which appears at the front of the first issue of each volume. The editors assume that papers sub mitted to *Parasitology* are not being considered for publication in other journals and do not contain material which has already been published.

INSTRUCTIONS TO AUTHORS

Manuscripts must be written in English and sent to the Editors, *Parasitology*, King's College, Strand, London WC2R 2LS, UK. The original manuscript and **one copy** should be submitted.

Submission of a manuscript implies that it has been approved by all the named authors, that it reports their unpublished work and that it is not being considered for publication elsewhere.

Before beginning to prepare a manuscript authors should refer to the *Instructions to Authors* which appears at the front of the first issue of each volume and to a current issue of *Parasitology* for the correct style. Manuscripts not prepared in the correct style usually have to be returned to the authors for revision.

- 1 Style. Manuscripts must be typewritten in double spacing on A4 paper. All pages should be numbered consecutively. There is no lower limit on manuscript size, provided that sufficient essential information is given. Unnecessarily long papers will be returned for revision.
 - (a) Title-page. A concise but informative full title plus a running title, name(s) of author(s) and address, including postal, zip or other code, of the institute where the work was carried out. Footnotes indicating present address may be included.
 - (b) Summary. A 150- to 200-word informative précis of the contents and conclusions of the paper.
 - (c) Introduction. The reasons for doing the work must be stated.
 - (d) Materials and Methods. Sufficient experimental details must be given so that methods can be reproduced by other workers.
 - (e) Results. As concise as possible. The use of both tables and figures to present the same data is not acceptable.
 - (f) Discussion. Must not recapitulate results in detail or contain new information but should emphasize the relevance and significance of the findings reported.
 - (g) Acknowledgements. If really appropriate.
 - (h) References. Only references directly relevant to the paper should be cited. Correct references are the responsibility of the author. The Harvard System must be used for the citation of references in the text as follows: Brown & Green (1980) or (Brown & Green, 1980). Where there are more than two authors the first citation should include all the names and subsequent citations should be in the form Brown et al. (1980) or (Brown et al. 1980). Where several papers by the same author(s) have been published in the same year they should be cited as Brown (1980a, b). Reference to unpublished observations, abstracts or papers 'in preparation should only be cited in exceptional circumstances. Citation of papers 'in press' is acceptable provided that the full title and journal are given. References must be listed in alphabetical order of authors' names. Both the title of the paper and of the journal should be given in full according to the following style:

Note that the authors' names are in capital letters and that the name of the journal is given in full.

Instructions to Authors

- 2 *Illustrations*. Each illustration should be supplied on a separate sheet and be labelled with the author's name and the figure or table number. The approximate position of figures and tables should be indicated in the text. If possible the maximum size of the illustration should not exceed A4 as larger packages are frequently damaged in the post.
 - (i) *Headings and legends*. Each table, figure or photograph should be supplied with an informative heading which together with an explanatory legend should provide enough details to make reference to the text unnecessary.
 - (ii) Line drawings. These should be drawn larger than the size of the finished figure. The maximum printed size of any drawing or group of drawings is 200×125 mm. Explanatory lettering will be inserted by the printers and should be indicated in soft pencil or on a tracing-paper overlay. Excessive lettering should be avoided on the figure and should be inserted in the legend. The preferred symbols for use in figures are \bigcirc , \triangle , \square , \blacksquare , \blacksquare , and for consistency the same symbols should be used to represent the same entity throughout the paper. Figures should be referred to in the text as Fig. 1; Figs 1-3.
 - (iii) Photographs. These should be mounted on thin card and should be approximately the same size as they are to appear in the journal and should not exceed 200×125 mm. Lettering on photographs may be inserted by the printers and should be indicated on a tracing-paper overlay. Alternatively, authors may label their photographs themselves. In this case the labelling should be Letraset Univers 53, 10 point for lettering and 12 point for numbers. Authors are asked to check their lettering carefully to avoid expensive remakes. Explanations of abbreviated lettering should be given as a separate list or included in the legend. Each photograph should be supplied with a scale bar with the appropriate units; magnification factors must *not* be given as an alternative. Mounting photographs is the responsibility of the author(s). Where several photographs make up a single unit, they should be accurately mounted on card and labelled.

Photographs will be inserted at the appropriate places in the text. They should be referred to as figures and numbered as such in the same way as line drawings in a common sequence.

- 3 The completed manuscript should be presented in the following order: Title page (including names of authors, addresses and running title), Summary, Introduction, Materials and Methods, Results, Discussion, Acknowledgements, References, Tables, Figures.
- 4 Editorial procedures. On receipt of the manuscript the editors will send an acknowledgement card containing the number of the manuscript which should be quoted in any subsequent correspondence. The manuscript will then be sent to the referees and the editors will accept, reject or request modifications after they have received the referees' reports. Authors will be informed of any editorial decision as soon as possible. After acceptance, the manuscript will be sent to the sub-editor who may make minor editorial changes before the paper is sent to press.
- 5 *Proofs.* Page proofs will be sent to the author by the Press. They will already have been proof-read by the Press for printer's errors but it is the responsibility of the author to ensure that the proof contains no errors. Only essential corrections should be made and authors may be charged for excessive alteration in proof.
- 6 Offprints. Authors will receive 50 offprints free of charge and may obtain additional copies from the Press if ordered at the proof stage.
- 7 Further information

Animals and organisms. The full binomial Latin name (underlined or in italics) should be given for all animals except common laboratory animals where the strain and source should be stated. Authors should follow the International Rules of Nomenclature for organisms and, if new names are introduced, the recommendations of the International Code of Zoological Nomenclature.

Solutions. Concentrations should be expressed in terms of molarity (M) not normality (N) and fractional concentrations should be given as 0.1 M/HCl not as M/10 HCl. Concentrations given as % must be defined as w/w, w/v or v/v. The complete composition of buffer systems should be given at the first mention. The names and addresses of manufacturers of special apparatus or materials should be stated. The EC numbers of enzymes should be given and nomenclature should follow the system published in the Report on the Commission on Enzymes of the International Union of Biochemistry.

Statistical treatment. Where possible, data from sufficient numbers of separate experiments should be reported to permit assessment of the reproducibility and significance of the results. Where a significant difference is claimed between the means of two groups of results, the test of significance used should be stated. It should be made clear whether the standard deviation or standard error has been used, and the number of separate experiments should be given.

S.I. units. S.I. units should be used and it is up to the author to check the use of an appropriate unit in a recent reference book.

Abbreviations. These should be used sparingly and should be spelled out in full on first use. The following list provides a guide to some of the commonly used abbreviations.

Instructions to Authors

TRENDS AND PERSPECTIVES IN PARASITOLOGY (TRAPS)

Trends and Perspectives in Parasitology (TRAPS) are published at intervals. These short reviews are intended to focus attention on developing or controversial aspects of parasitology, identify new or old problems in need of research, suggest how research in other areas of biology might relate to parasitology and to present students and teachers with concise summaries of particular topics. TRAPS are not intended to be definitive reviews nor do they seek to duplicate areas well covered elsewhere.

Most TRAPS are solicited by the editors who also welcome informal suggestions for titles and/or authors. In particular, an author preparing a standard *Parasitology* manuscript may find that the subject might well be more suitable for a TRAPS. Authors are requested not to send unsolicited TRAPS but to discuss the matter with the editors in the first instance.
