# THE SHILOAH CENTER FOR MIDDLE EASTERN AND AFRICAN STUDIES Tel Aviv University

The Shiloah Center forms a community composed of faculty members, Visiting Research Associates and Fellows (from other academic and non-academic institutions), professional research staff and postgraduate students. It provides the framework and facilities for integrating research with study towards academic degrees, for documentation and collection of sources, and for the supply of information and analyses to those concerned.

The Research Committee advises the Center on all matters of research and co-ordinates the Center's work with that of other research institutions in Israel. The Committee comprises professors from other Departments of the University and from other universities in Israel, representatives of government bodies concerned with the Middle East and Africa, some of the foremost Israeli experts in the field, and the Senior Research Fellows of the Center itself.

Periodically, a sub-Committee examines research projects submitted to it, ratifies such projects as meet the criteria of the Center, and appoints the annual Visiting Research Associates and Fellows.

Visiting Research Associates and Fellows are generally scholars and experts from other institutions and universities, both in Israel and from abroad, who join the Center to carry out specific research projects. The Center annually offers two full-salaried posts for Visiting Research Associates and Fellows. Applications and outlines of the proposed projects are submitted to the Center not later than six months before the beginning of the academic year (October).
